I. INTRODUCTION

Managed Transportation Services Inc. dba Four Star Limousine (hereinafter “transferor”), is the holder of Livery Permit No. 2147, last issued by the Department of Transportation (hereinafter “Department”) on January 4, 2008, authorizing the operation of:

1. Nine (9) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service between all points in Connecticut from a headquarters in Waterbury.
2. One (1) limousine type motor vehicle in general livery service from a headquarters in Bristol
3. Six (6) motor vehicles in general livery service from a headquarters in Hartford

On October 7, 2019, David Byrne, Vice President, revoked the Bristol and Hartford locations, reducing the authority to the following permitted and authorized vehicles:

1. Nine (9) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service between all points in Connecticut from a headquarters in Waterbury.

Therefore, Managed Transportation Services Inc. dba Four Star Limousine, holder of Livery Permit No. 2147, is permitted and authorized to operate the following:

1. Nine (9) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service between all points in Connecticut from a headquarters in Waterbury.

II. APPLICANTS' PROPOSAL

By joint application filed on October 30, 2019 and given Application No. 1910-S-118-L, the applicants seek Department approval of the sale and transfer of the authority granted under Livery Permit No. 2147 from the transferor to Connecticut Transportation Solutions LLC (hereinafter “transferee”).

III. FINDINGS OF FACT

1. The applicants have submitted the proper application before the Department.
2. After a review of the transferor’s records, it was determined that eight (8) of the nine (9) authorized vehicles are registered. The one (1) unregistered vehicle is not compliant, not authorized for sale or transfer, and therefore, is revoked at the time of sale.
3. The transferee is financially able to staff, equip and operate the livery service transferred herein.
4. The required Criminal Conviction History Report (CCHR) was filed with the application.
5. The Purchase Agreement was submitted with the application.
6. Proof of sufficient insurance coverage for the transferee was submitted with the application.

IV. CONCLUSION

The transferee retains its current name and takes on the transferor’s livery permit number and authority.

Therefore, based upon the facts stated above, and pursuant to section 13b-103, the Department hereby approves the sale and transfer of the authority granted under the transferor's livery permit as proposed, to the transferee. Following the approval of this sale and transfer, Managed Transportation Services Inc. dba Four Star Limousine will retain no rights to the authority transferred and Livery Permit Number 2147, held in the name of Managed Transportation Services Inc. dba Four Star Limousine, is hereby amended, and reissued in the following form:

LIVERY PERMIT NO. 2147
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Connecticut Transportation Solutions LLC is hereby permitted and authorized, in accordance with and under the provisions of the General Statutes, as amended, to operate:

1. Eight (8) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service between all points in Connecticut from a headquarters in Waterbury.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

The authority transferred may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 1910-S-118-L, the authority granted herein will be revoked.

This permit is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations and orders as this Department may from time to time prescribe.

A memorandum of this permit, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicles operated hereunder.
