APPLICATION OF AVERY CAB LLC, HOLDER OF CERTIFICATE NUMBER 1179, TO OPERATE ONE (1) ADDITIONAL MOTOR VEHICLE IN TAXICAB SERVICE WITHOUT A HEARING.

I. INTRODUCTION

By application filed on December 3, 2020 with the Department of Transportation (hereinafter "Department"), pursuant to Section 13b-97(a) of the Connecticut General Statutes, as amended, and Section 13b-96-8 of the Connecticut State Agency Regulations, as amended, Avery Cab, LLC (hereinafter "applicant") seeks authorization to operate one (1) additional motor vehicle in taxicab service within and to and from the towns of South Windsor, East Windsor and Windsor Locks. The applicant, holder of Certificate Number 1179, is currently authorized to operate five (5) motor vehicles in taxicab service within and to and from the towns as follows:

- 1. One (1) motor vehicles in taxicab service within and to and from Bloomfield, East Hartford, East Windsor, Enfield, Farmington, Granby, Hartford, Manchester, Newington, Rocky Hill, South Windsor, Simsbury, Vernon, West Hartford, Wethersfield, Windsor
- 2. One (1) motor vehicle in taxicab service within and to and from Stafford and Union.
- 3. One (1) motor vehicle in taxicab service within and to and from Colchester, East Haddam, Hebron, Marlborough, Lebanon and Salem
- 4. One (1) motor vehicle in taxicab service within and to and from East Hampton
- 5. One (1) motor vehicle in taxicab service within and to and from Ellington, East Windsor, Vernon, South Windsor, and Windsor Locks.

II. DEPARTMENT ANALYSIS

- 1. The applicant has submitted the proper application before the Department.
- 2. The applicant has held Certificate Number 1179 for at least one year.
- 3. The last time the applicant was authorized for additional vehicles was on June 23, 2008. The Department reviewed the file history and found some prior errors and the Conclusion and Order listed below will correct all errors on previous Final Decisions and add the request for one (1) additional vehicle and its territories.
- 4. The Department records indicate that all the existing plates held by the applicant are registered and in use.
- 5. The Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

III. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-97(a), the instant application given Application Number 2012-EXP-66-T is hereby approved and therefore Certificate Number 1179 is hereby amended and reissued to and from the towns as follows:

CERTIFICATE NUMBER 1179 FOR THE OPERATION OF VEHICLES IN TAXICAB SERVICE

Avery Cab, LLC is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate a total of six (6) motor vehicles in taxicab service as follows:

- 1. One (1) motor vehicles in taxicab service within and to and from Bloomfield, East Hartford, East Windsor, Enfield, Farmington, Granby, Hartford, Manchester, Newington, Rocky Hill, South Windsor, Simsbury, Vernon, West Hartford, Wethersfield, Windsor.
- 2. One (1) motor vehicle in taxicab service within and to and from Stafford and Union.
- 3. One (1) motor vehicle in taxicab service within and to and from Colchester, East Haddam, Hebron, Marlborough, Lebanon and Salem.
- 4. One (1) motor vehicle in taxicab service within and to and from East Hampton.
- 5. One (1) motor vehicle in taxicab service within and to and from Ellington, East Windsor, Vernon, South Windsor, and Windsor Locks.
- 6. One (1) motor vehicle in taxicab service within and to and from South Windsor, East Windsor, and Windsor Locks.

The authority granted in application 2012-EXP-66-T may not be sold or transferred until it has been in operation, i.e., a vehicle registered with taxicab plates thereunder, for no less than twenty-four (24) consecutive months. If during the twenty-four (24) month period the applicant enters into a contract for the full sale or transfer of any of the vehicles authorized herein, the authority granted in application 2012-EXP-66-T will be revoked.

This certificate shall remain in effect until revoked by the Department. Failure of the certificate holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other state statutes and/or the rules, regulations, and orders of the Department shall be considered sufficient cause to revoke said certificate.

This certificate is transferable only with the approval of the Department and is issued subject to compliance by the holder hereof with all motor vehicle laws of the State of Connecticut, and with such rules, regulations, and orders as this Department may from time to time prescribe thereunder.

A memorandum of this certificate, bearing the seal of the Department, shall be kept conspicuously posted in each motor vehicle operated under this certificate.
