REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION
AUTHORITY

By application 2103-I-23-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on March 29, 2021, Quiet Corner Transport LLC dba QC Transport (hereinafter "applicant"), seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-1252202, issued on June 11, 2021. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3701 is issued to Quiet Corner Transport LLC dba QC Transport in the following form:

LIVERY PERMIT NUMBER 3701

Quiet Corner Transport LLC dba QC Transport is authorized to operate three (3) motor vehicles in general livery service, with a seating capacity of less than (11) eleven passengers from a headquarters in Brooklyn.

Furthermore, Quiet Corner Transport LLC dba QC Transport is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-1252202.

RESTRICTIONS:

The authority granted under this permit may not be sold or transferred until it has been operational, i.e. a vehicle registered with livery plates, thereunder, for not less than twenty-four (24) months from the date of the original issuance, January 21, 2021.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**
