I. INTRODUCTION

A. <u>Applicant's Proposal</u>

By application filed on May 17, 2022, pursuant to Section 13b-389 of the Connecticut

General Statutes and assigned Docket No. 2205-N-49-HG, Real Moving LLC ("hereinafter applicant"), with a mailing address of One Pine Street, Sandy Hook, CT 06482 seeks authorization from the Connecticut Department of Transportation (hereinafter "department") to operate motor vehicles in the transportation of household goods for hire, as a household goods carrier, over irregular routes between all points in Connecticut from a headquarters in Bethel.

B. Hearing

Pursuant to Connecticut General Statutes Section 13b-391, a hearing is not required on this application.

Notice of the application was not given to interested parties in the municipality due to no household goods carriers in the municipality of Bethel.

II. <u>FINDING OF FACT</u>

- 1. The applicant is seeking to operate an intrastate household goods moving company from a headquarters in Bethel.
- 2. Lucas Botelho Francapinto has worked in the moving business since 2002 as a helper and in 2004 stated as a driver for Braun Moving Inc.
- 3. Lucas Botelho Francopinto has been in the moving company industry for the past 19 years and has done thousands of local and long-distance moving jobs.
- 4. The applicant is performing local and long-distant moving jobs as an owner operator for Joyce Van Lines until his permit is approved.
- 5. The applicant has a \$ 3,412.60 balance in its business bank account.
- 6. The applicant will be operating a 2016 International box truck, a 2020 Dodge Ram cargo van and a 2004 International box truck in the moving business.
- 7. The applicant's first six months of expenses includes insurance costs of \$ 9,312.79, vehicle financing of \$ 9,391.86, maintenance and repairs of \$ 1,500.00, property tax of \$ 1,925.77, advertising costs of \$ 2,100.00 and communications costs of \$ 720.00.
- 8. Lucas Botelho Francopinto will be running the business himself.
- 9. Lucas Botelho Francopinto has a clean criminal record.
- 10. The applicant receives several requests for intrastate moving services every week which he cannot perform because he is not authorized.
- 11. There was no opposition to a grant of this application.

III. DEPARTMENT ANALYSIS AND CONCLUSIONS OF LAW

The Department of Transportation has jurisdiction over any person operating any motor vehicle in the transportation of household goods for hire as a household goods carrier pursuant to Section 13b-389 of the Connecticut General Statutes. Further, no personal shall operate as a household goods carrier, within Connecticut, without first obtaining a certificate of public convenience and necessity to so operate.

In determining whether such a certificate shall be granted, the Commissioner of Transportation shall take into consideration the existing motor transportation facilities and the effect upon them of granting such a certificate, the suitability of the applicant, the financial responsibility of the applicant, the ability of the applicant to efficiently perform the service for which the authority is requested, and the criminal history of the applicant pursuant to Section 13b-392 of the Connecticut General Statues.

As far as the applicant's financial ability is concerned, the applicant presented evidence of insurance costs of insurance costs of \$ 9,312.79, vehicle financing of \$ 9,391.86, maintenance and repairs of \$ 1,500.00, property tax of \$ 1,925.77, advertising costs of \$ 2,100.00 and communications costs of \$ 720.00 for a total expense of \$ 24,950.42. The applicant has \$ 28,363.02 in a business bank account which is sufficient to cover these costs thereby making the applicant financially suitable.

The applicant submitted a criminal record check for Lucas Botelho Francopinto which showed no criminal record. The applicant has prior experience having worked for several moving companies. In addition, the applicant has been in the moving company industry for the past 19 years and has done thousands of local and long-distance moving jobs. Based on the evidence presented, the applicant is suitable to handle this proposed operation.

Another factor to be considered is the ability of the applicant to efficiently perform the service for which the authority is requested. The applicant plans to utilize a 2016 International box truck, a 2020 Dodge Ram cargo van and a 2004 International box truck for the business. The applicant's three (3) vehicles will enable efficient performance of duties.

The last criterion to be considered is the effect on the existing motor carrier facilities by granting this certificate. No moving companies have opposed the application indicating that there would be little, if any, effect on the operators in that area.

Based on the evidence provided, the applicant has proven all the necessary elements to be granted a certificate to operate a household goods moving company from a headquarters in Bethel.

IV. ORDER

Based upon the above and pursuant to Section 13b-391 of the Connecticut General Statutes, the application of Real Moving LLC is hereby granted, and Certificate Number HG1818 is issued as follows:

<u>CERTIFICATE NUMBER HG1818</u> <u>TO OPERATE MOTOR VEHICLES FOR THE TRANSPORTATION OF PROPERTY</u> <u>FOR HIRE AS A MOTOR COMMON CARRIER</u>

Real Moving LLC, is hereby permitted and authorized, subject to such regulations and conditions as the department may from time to time prescribe, to transport property for hire as a motor common carrier over irregular routes as follows:

Household goods, within the State of Connecticut, between all points upon calls received at its headquarters in Bethel.

The certificate holder must accept and transport property, as herein authorized in accordance with its tariff on file, for all persons who desire the service to the extent of the certificate holder's facilities at uniform rates for all similar service.

CONDITIONS:

A motor vehicle must be registered and insured under this certificate within ninety (90) days from the date of this decision. Failure to so may result in a revocation of authority.

There shall be carried in each vehicle operated under this authority a copy of the certificate of registration receipt issued by the department.

The certificate shall remain in effect until suspended, amended or revoked by the department. Failure of the certificate holder to maintain proper insurance or to comply with all motor vehicle laws and other pertinent state statutes and/or the rules, regulations and orders of the department shall be considered sufficient cause to revoke said certificate.

This certificate may not be sold or transferred until it has been operational for more than twenty-four (24) months.

This certificate is transferable only with the approval of the department and is issued subject to compliance by the holder thereof with all motor vehicle laws of the State of Connecticut, and with such regulations and orders as this department may from time to time prescribe.
