INTRODUCTION

By application filed on May 2, 2022, with the Department of Transportation (hereinafter "Department"), Care for you LLC (hereinafter "applicant") has re-entitled its authority to Care for You Transportation Limited Liability Company. This revision and reissuance include the paragraph that refers to the restriction concerning sale and transfer. Therefore, Livery Permit Number 3680 is amended and re-issued as follows:

LIVERY PERMIT NUMBER 3680
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Care for You Transportation Limited Liability Company is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate two (2) motor vehicles, each having a passenger seating capacity of eleven (11) passengers or less, in general livery service between all points in Connecticut from a headquarters in Bloomfield.

This permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 2103-AVWO-17-L, the authority granted herein will be revoked.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A Memorandum of the permit bearing the seal of the Department, shall be kept conspicuously posted in each motor vehicle operated hereunder.
