REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION
AUTHORITY

By application 2206-I-68-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on June 28, 2022, Luxe Ambassador Transportation of Hartford, Inc. (hereinafter "applicant"), seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-1400417-C, issued on June 10, 2022. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3724 is issued to Luxe Ambassador Transportation of Hartford, Inc. in the following form:

LIVERY PERMIT NUMBER 3724
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Luxe Ambassador Transportation of Hartford, Inc is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-1400417-C.

Luxe Ambassador Transportation of Hartford, Inc. is authorized to operate Five (5) motor vehicles in general livery service, with a seating capacity of less than eleven passengers, from a headquarters in Rocky Hill.

RESTRICTIONS

Luxe Ambassador Transportation of Hartford, Inc. is only permitted to use their complete legal company name, Luxe Ambassador Transportation of Hartford, Inc., in any digital or print advertising, and they are prohibited from using a shortened version of their name, including in a website address.

The authority granted under this permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder for not less than twenty-four (24) months from the date of this final decision. If at any time during the twenty-four (24-month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 2203-AVWO-27-L, the authority granted herein will be revoked.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle

laws and other State statutes and/ or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicles operated hereunder.
