**REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION**  
**AUTHORITY**

By application 2210-I-100-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on October 25, 2022, Athletic Limo LLC (hereinafter "applicant"), seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-01477743, issued on October 20, 2022. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3755 is revised and re-issued to Athletic Limo LLC in the following form:

**LIVERY PERMIT NUMBER 3755**

Athletic Limo LLC is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-01477743.

Athletic Limo LLC is also authorized to operate one (1) motor vehicle in general livery service, with a seating capacity of less than eleven passengers, from a headquarters in Trumbull.

**RESTRICTIONS**

The authority granted under this permit may not be sold or transferred until it has been operational, i.e. a vehicle registered with livery plates thereunder for not less than twenty-four (24) months.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke said permit. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**

A memorandum of the permit bearing the seal of the Department shall be kept conspicuously posted in the motor vehicles operated hereunder.
