**Public Trans.** – Must request approval through the Department's Bureau of Public Transportation (Attn: Mr. Peter Montana at 860-594-3186, <a href="mailto:Peter.Montana@ct.gov">Peter.Montana@ct.gov</a>)

**Traffic** – Must request approval through the Department's Division of Traffic Engineering Division Chief DOT.TrafficEngineering@ct.gov
