# - State Bike-Ped Plan

2<sup>nd</sup> steering committee reviewed vision and goals and refine overall vision of plan, then routing/mapping exercise and had outreach meeting, all minutes posted on <a href="https://www.bikepedplan.org">www.bikepedplan.org</a> website.

# - Community Connectivity Program

Underway, DOT and Consultant reaching out to towns who applied, and all towns that applied will have at least one RSA completed, hoping to do 2-3 per week General requests have been corridors and many on state routes, some are specific intersections

2<sup>nd</sup> part of program – meeting next week with steering committee (June 3), regions, towns and members of board and DOT staff in process to figure out how to move these towards construction projects

Moving forward, steering committee from non-motorized users, consultant incorporated comments and has draft to be submitted shortly

# - Project tracking/ process example

DOT is working on this effort and will have an engineer come to next meeting to show complete streets process and how it works within DOT

Board requested a typical project showing how complete streets were considered, such as bridge/culvert project examples and a repaving project

#### Other

Next month meeting – time for founder of bike tag, device attached to bicycle that links up with strava and similar things as app, crash detection, texting alerts and reporting of hazardous conditions, senses impacts and sends text to family. The Board asked that DOT provide us with a link to the company's website and the Board will consider next month if we want a presentation.

DOT has just begun thinking about this and it might become a small pilot?

Putnam Bridge moving forward, met with Goodwin College as a possible additional north route along the river to Charter Oak Bridge

Gap closure funding, no report, but all State funding at risk with funding situation

Rumble strips along State routes list – is DOT considering bike routes in the implementation? Kevin believes this is the case and expects that the rumble strips will be bike friendly designs. He will check into this.

Suggestion for DOT/OSTA to assess bike path crossings at intersections for restrictions of RTOR – the Board will consider this as a recommendation for our next annual report.

Leading pedestrian interval approved by OSTA Tresser at Washington Blvd in Stamford. This is the first LPI approved in the state.

# 2.3 Bike Walk CT Update

Bike Walk is looking to do more outreach and holding meetings in other Towns. Currently they are without an executive director, they expect to fill the position on a parttime basis. BikeWalk Summit – June 2 walkability workshop and June 3 at CCSU

Kelly and Tom Gutman are no longer serving on the CTBPAB, so 2 positions open on CTBPAB
