We want to discuss how we can be most effective. It was noted that a couple of states have taken interesting approached – NY \$110 million pedestrian safety initiative that includes several departments and initiatives including crash data analysis, engineering, education and enforcement. Delaware is using its state bike ped advisory board to help select local projects for funding to plan bike ped projects.

State Board of Education contact being researched – Emily Francis is to reach out to MPOs

Al is to find a contact with the state police.

Regarding municipal recommendations, we have not determined the best way to reach out to municipalities, other than outreach to LTA's or to provide workshops, like the CCM workshop delivered last year.

Rod and Deb to draft letter to Transportation Committee discussing our legislative recommendations: legislation to change the crosswalk statute to require yielding when a ped is at the crosswalk *(currently says in the crosswalk) and to request that the Office of Legislative Research examine issues related to electric assist bicycles.
