DOT reports: Update from Active Transportation Unit

HDR preparing the Active Transportation Plan, middle of June will be the kick off meeting for consultant and DOT, the project is expected to take 2 years. Anna can share the scope of work after the kick off meeting. As part of the plan the Consultant will organize and categorize roads based on surroundings (context sensitive classification). Committees will be created to guide the plan.

Charter Oak Greenway Trail cracks filled by DOT, and a section was repaved. A plan for repairs is being developed for the section by Manchester Community College.

Bissell Bridge project improvements to path within the project limits and South Windsor Town Engineer comments on the trail approaches. Anna will raise the issue regarding transverse cracks on the trail outside the project area. DOT is currently working on a maintenance plan for trails.
