# Funding for Project

---

## Traditional Fed. Local Program:

- 80% Federal and 20% Town for Design, ROW, and CN

## DMS:

- Design, ROW, and CN Phases are funded with 80% Federal and 20% State Funds
- Design is at zero cost to the Towns
- Design is “Full Partnership” and Coordination with the Town

## Goals of DMS

- Provide a “Streamlined approach to Design” using full DOT resources
- Aid the Towns to Keep their bridges in “State of Good Repair” by effective use of funds
- Decrease typical design time
- Utilize Accelerated Bridge Construction (ABC) techniques to shorten construction duration
- Increase the number of municipal projects delivered to construction each year

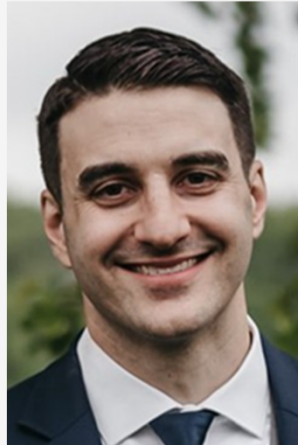

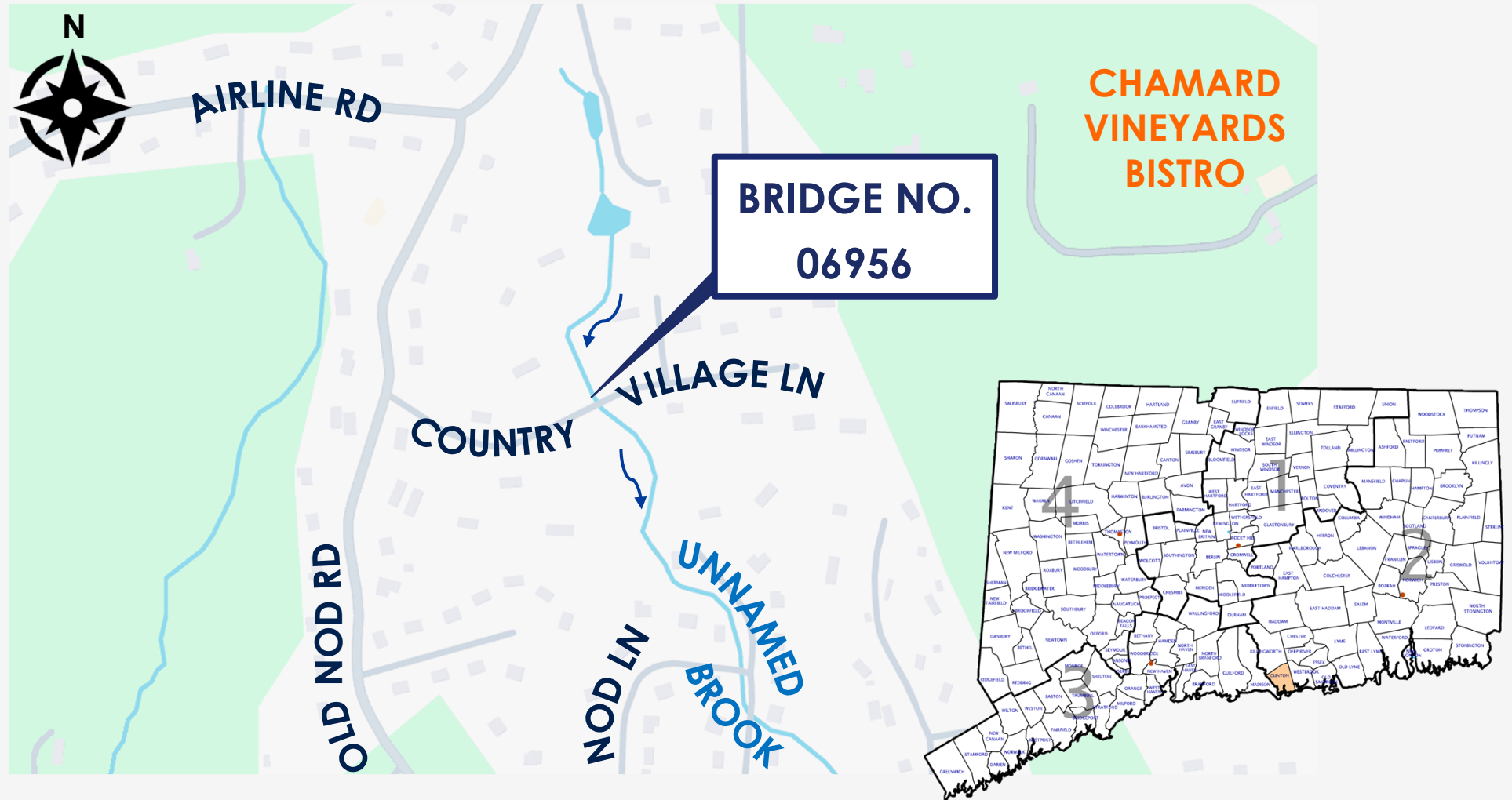

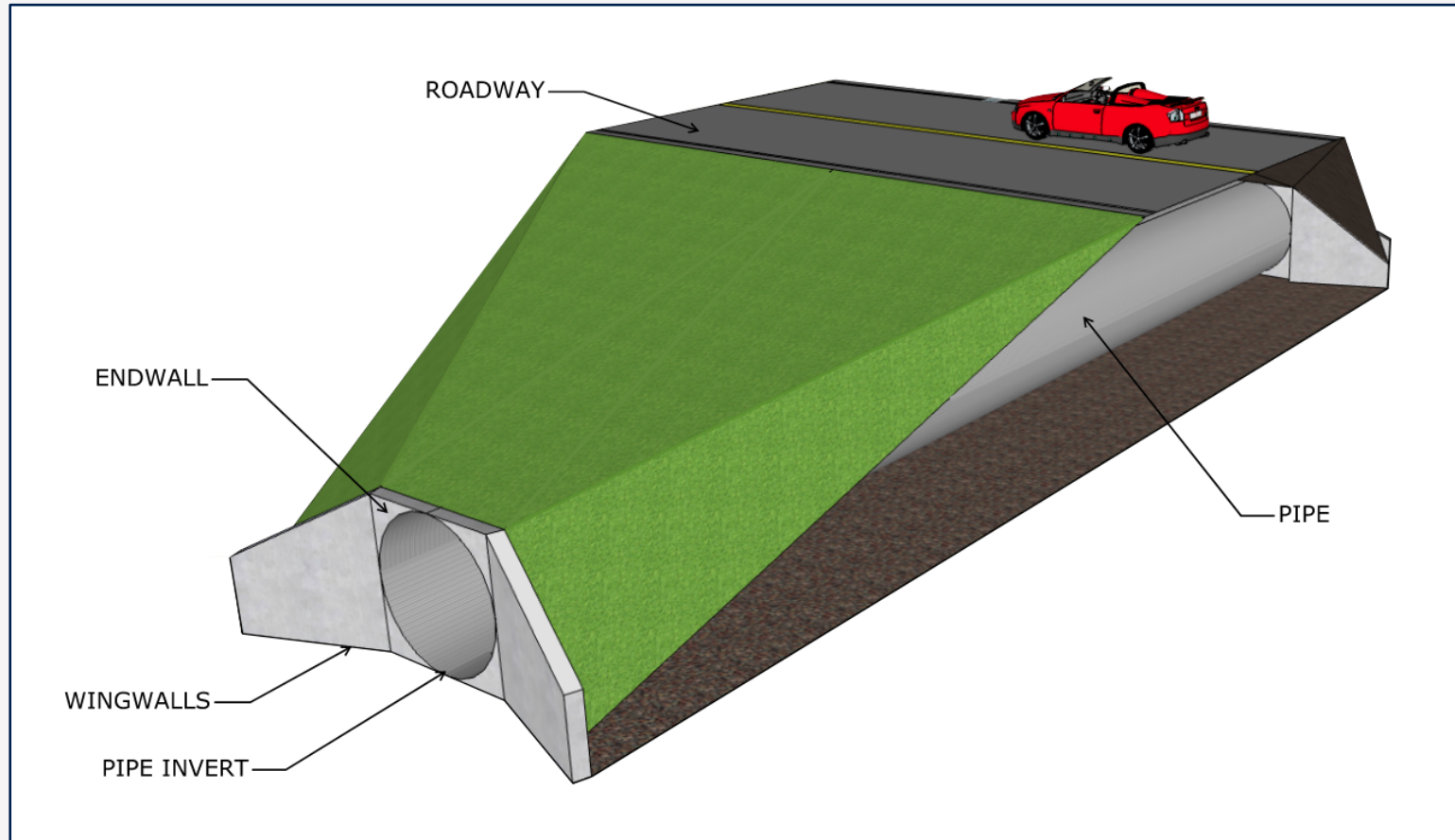

- 1 – Imminent Failure

- Four (4) 49 LF – Corrugated Steel Arch Pipe Culverts with Concrete Headwall and Endwall
- Constructed in 1970
- ADT = 100 vehicles (Estimated)

Condition (09/24/2024 Inspection Report)

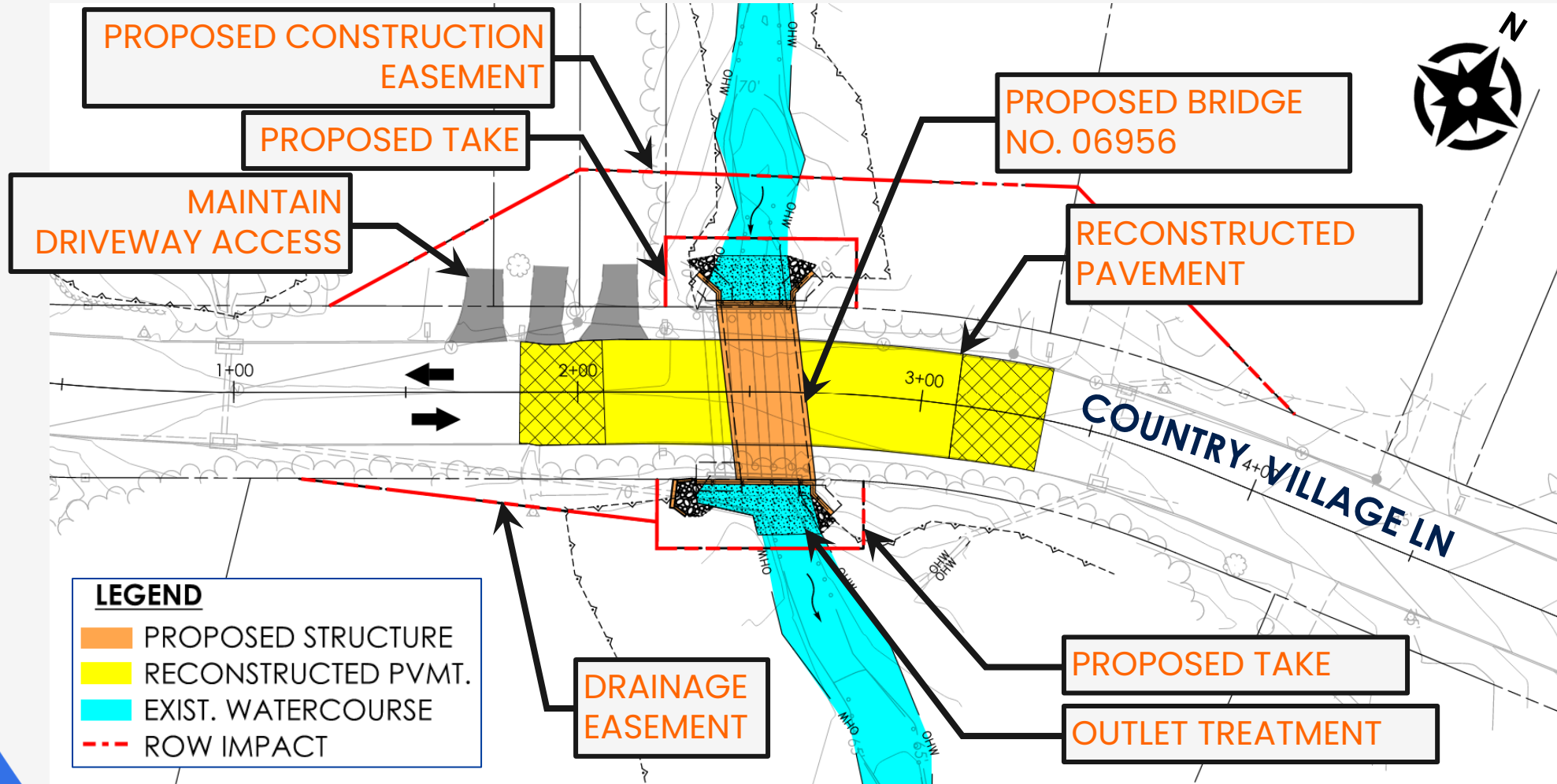
Culvert = 2

- Undermining Up to 12"

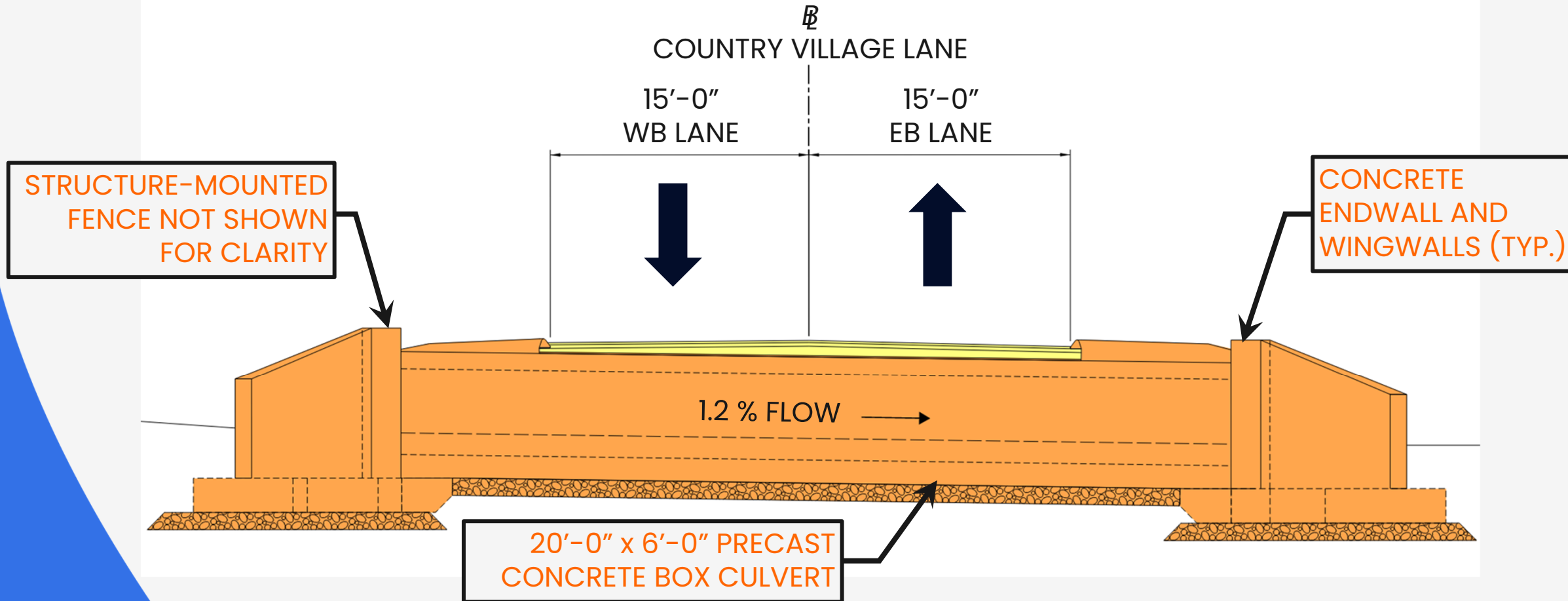




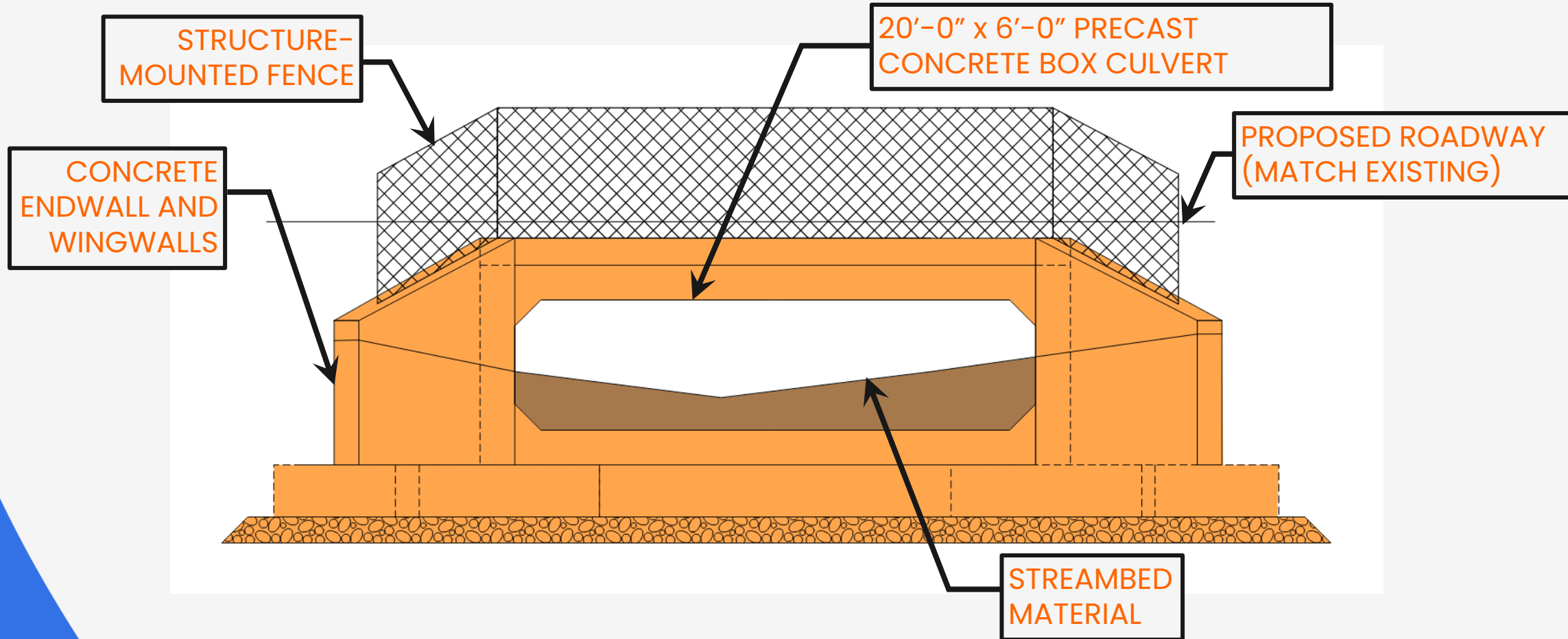
# Proposed Bridge Replacement | Plan View



# Proposed Bridge Replacement | Section View

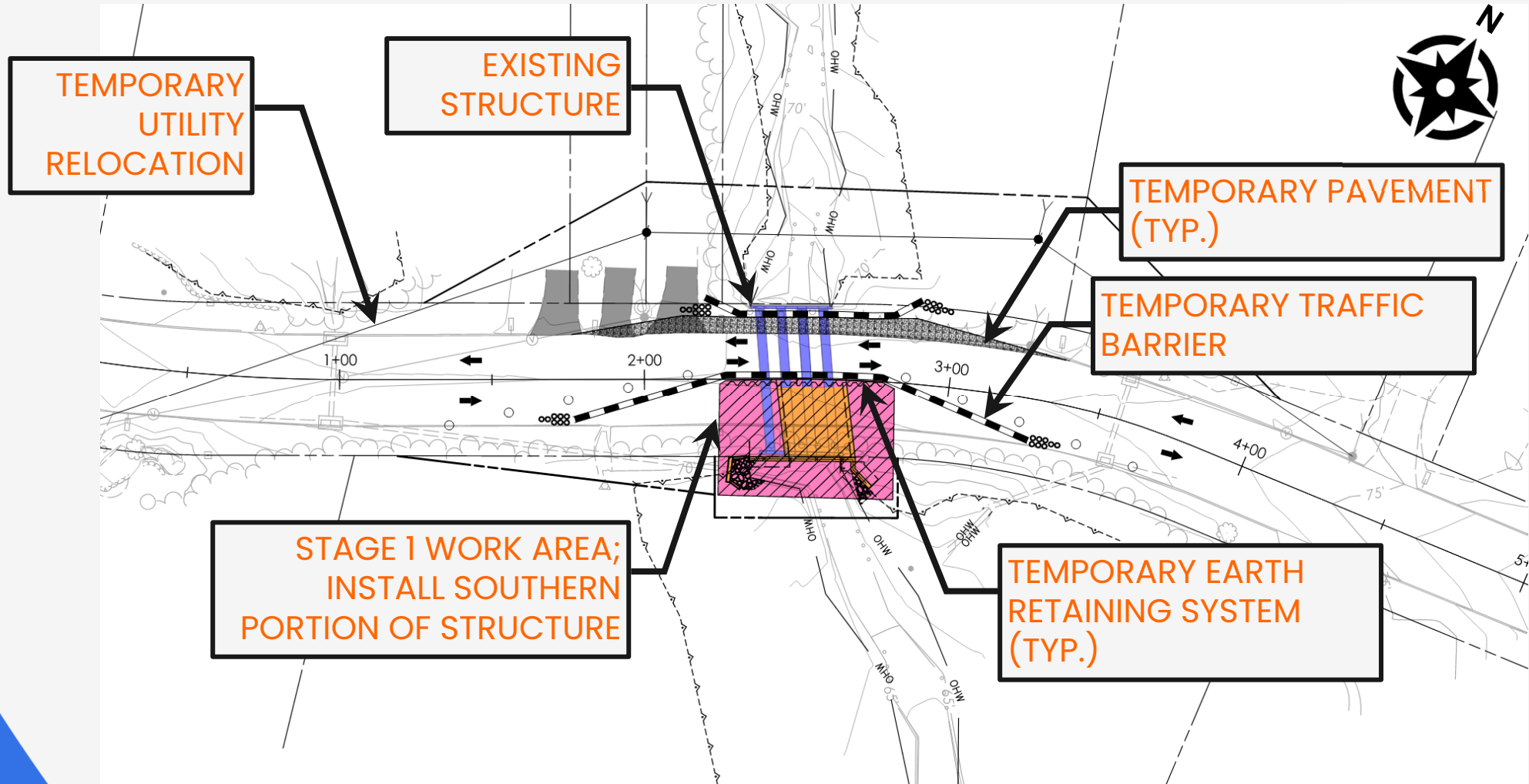

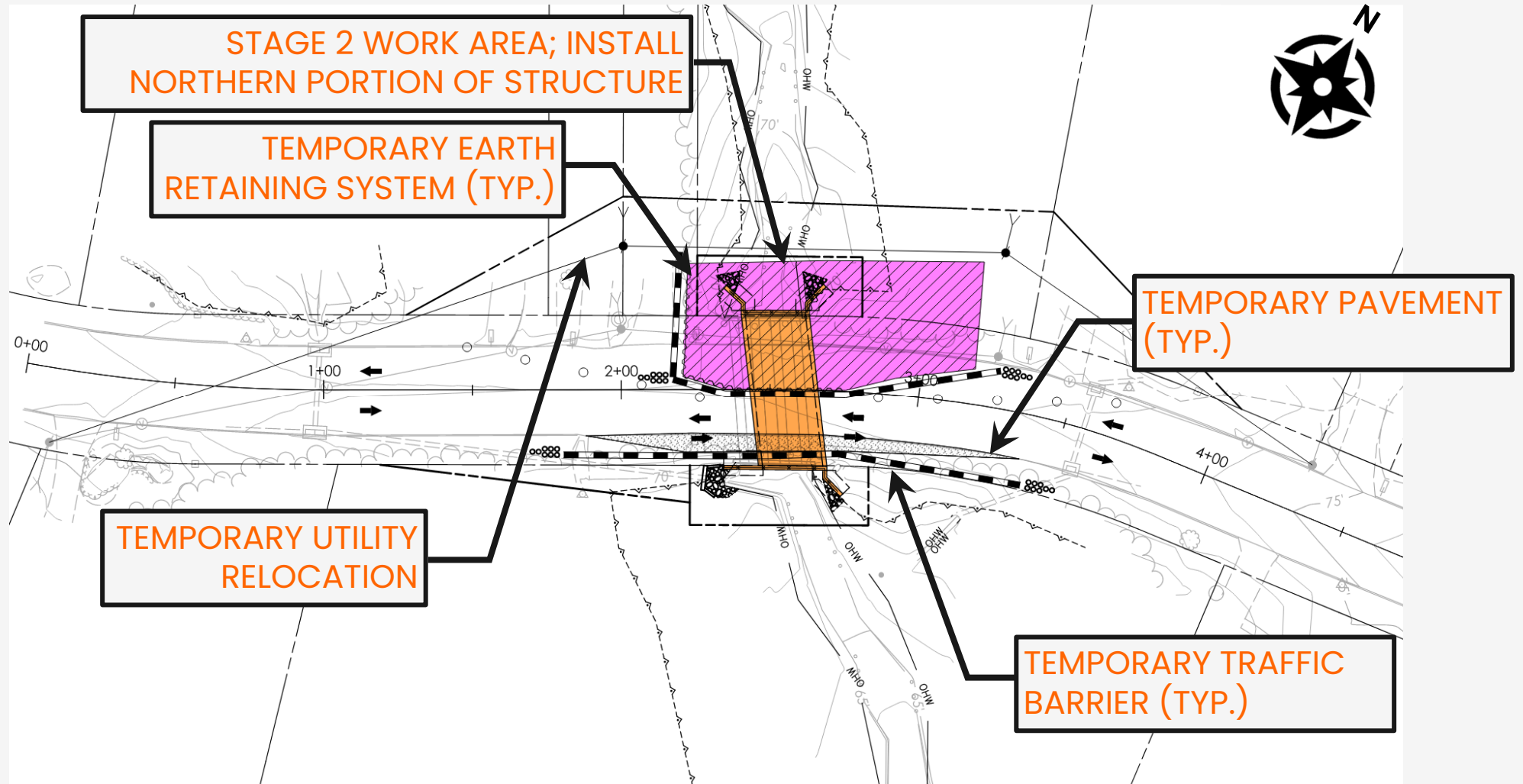

## Utilities

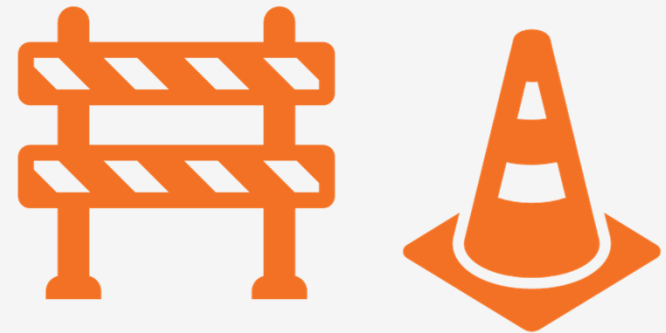
- Aerial Utilities Will Be Temporarily Relocated to the North and Will Be Relocated to Their Existing Location at the End of Construction.

## Environmental Permits

- Town of Clinton Inland Wetland Permit
- Connecticut Department of Energy & Environmental Protection Flood Management Certification

## Right-of-Way

- Two (2) Partial Property Takes
- One (1) Construction Easement
- One (1) Drainage Right of Way Easement

- Acquire All Property/Property Rights Necessary for the Project.

- Federal: Federal: Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as Amended.

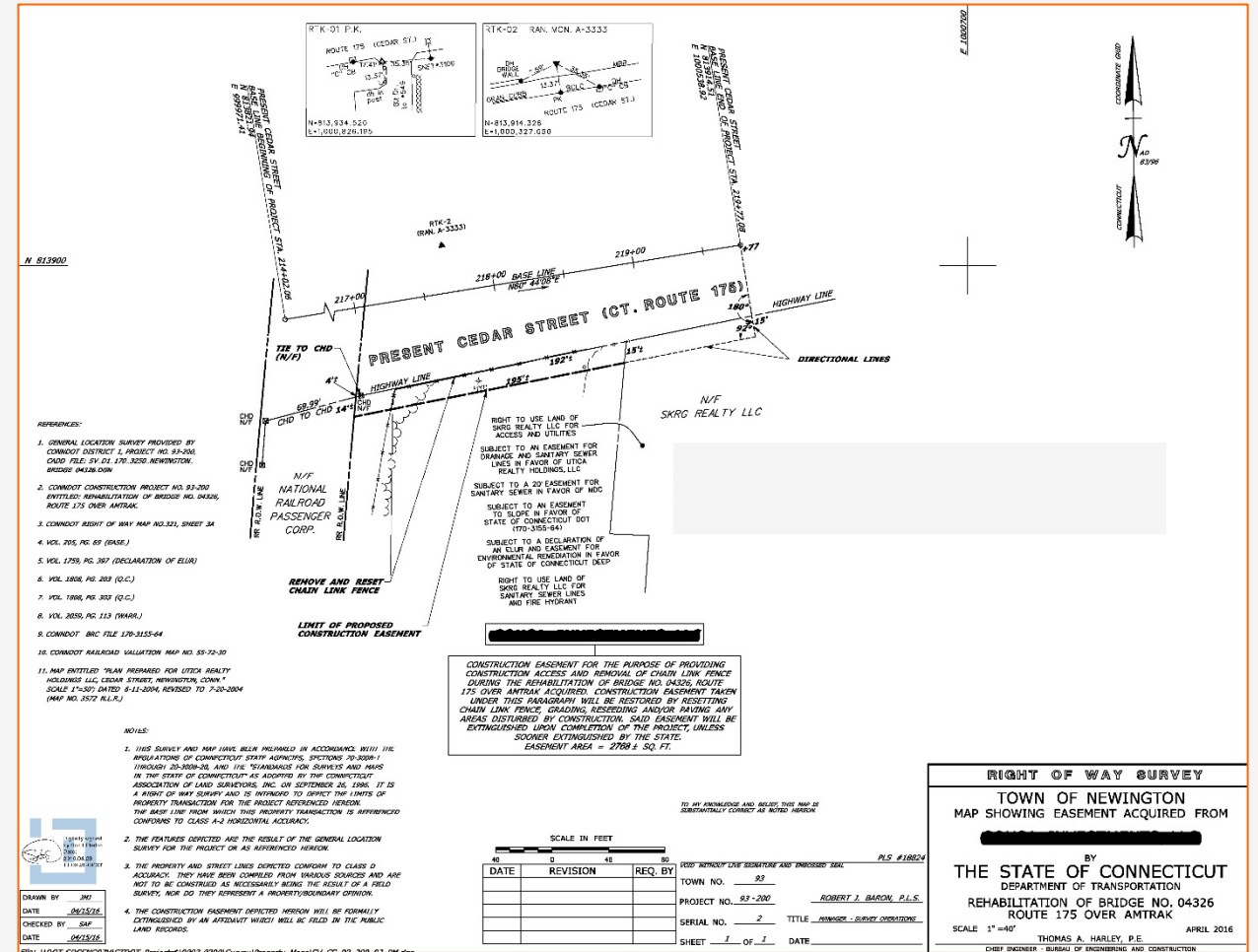

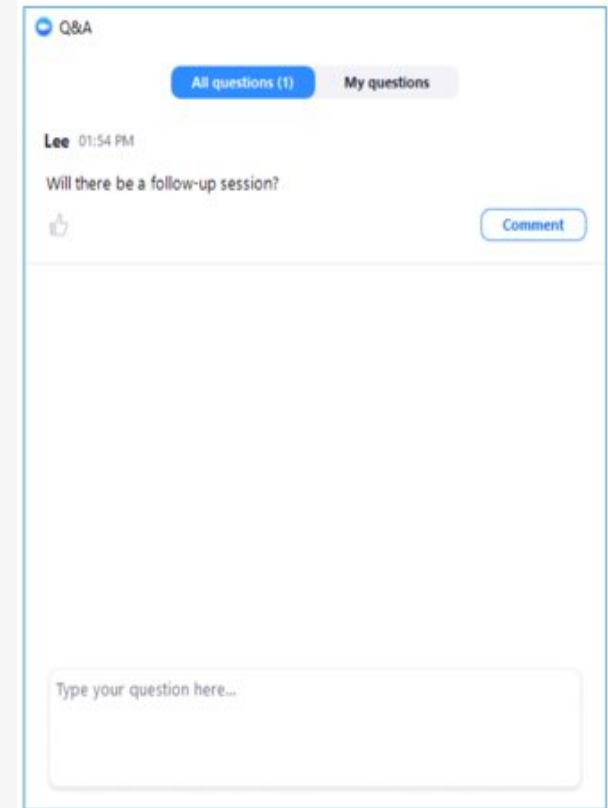
