Alternative Project Delivery Method

CTDOT provides a Base Technical Concept (BTC) and Project Requirements

Design-Build Team

- Contractor and Designer Team Selected Based on Best Value
- Best Value = Qualifications + Price + Technical Approach

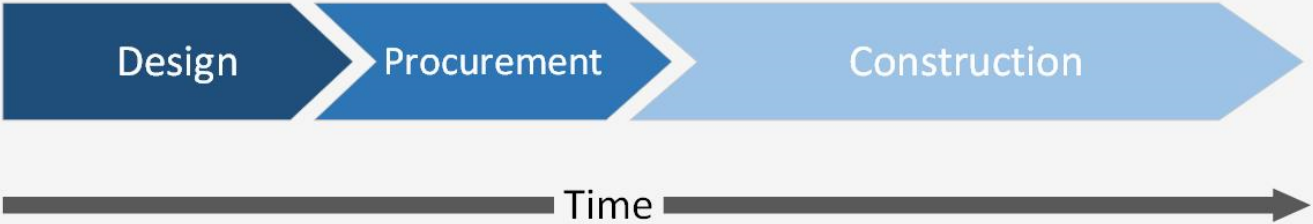
Selected Team

- Completes Final Design
- Constructs the Project Based on Accepted Design

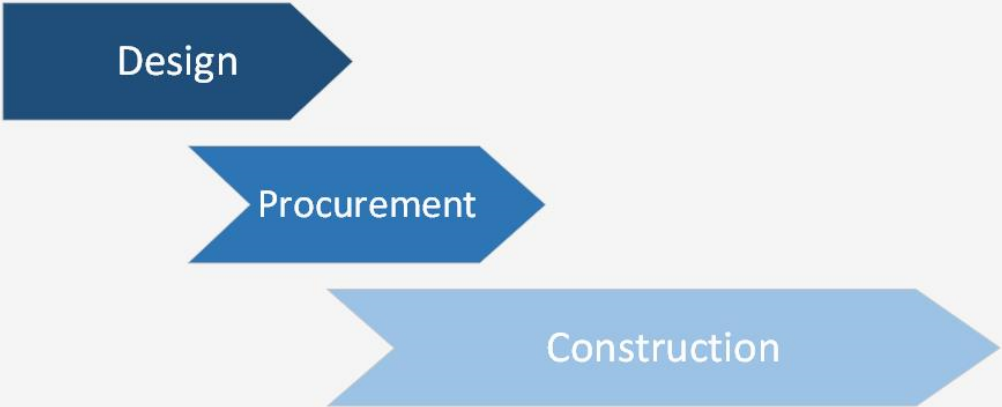

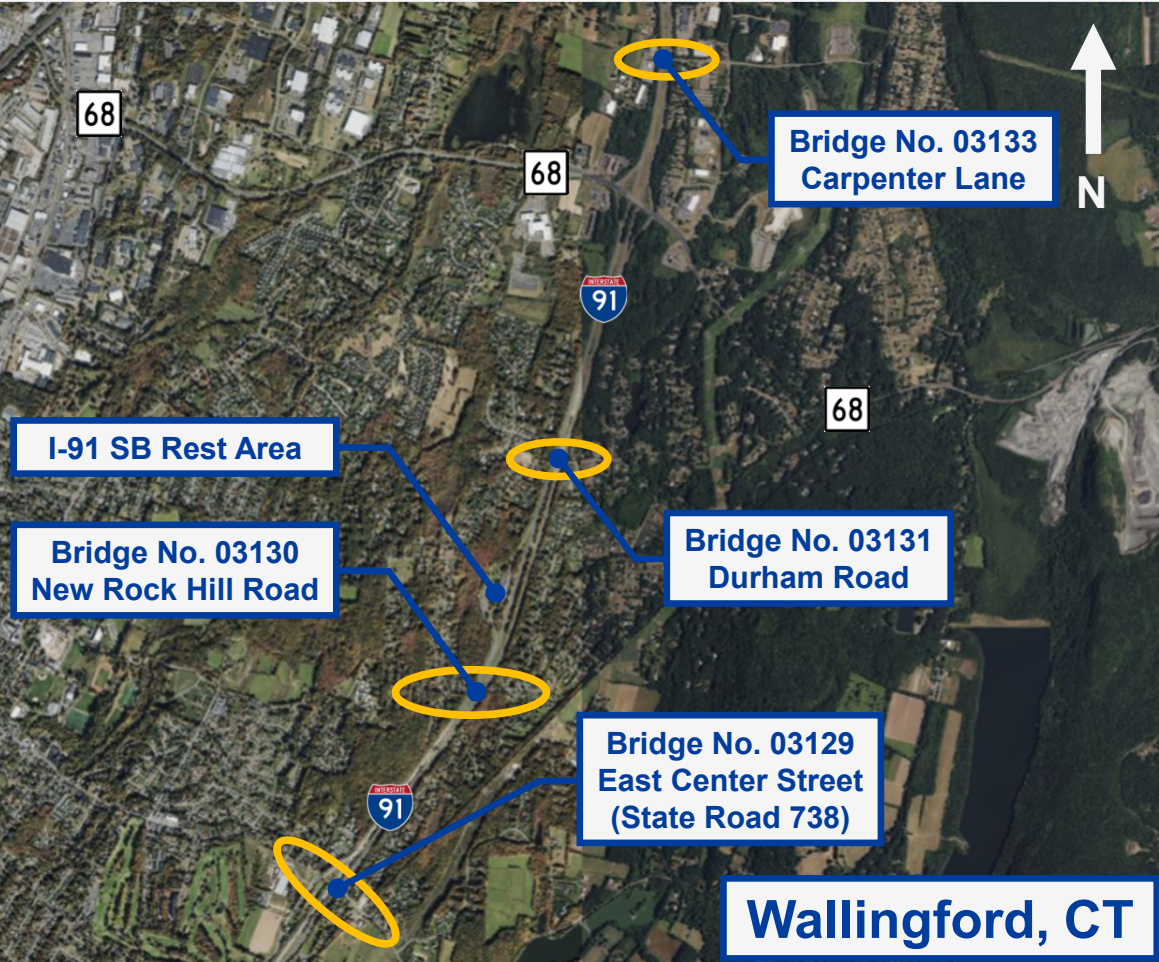

- Carpenter Lane over I-91

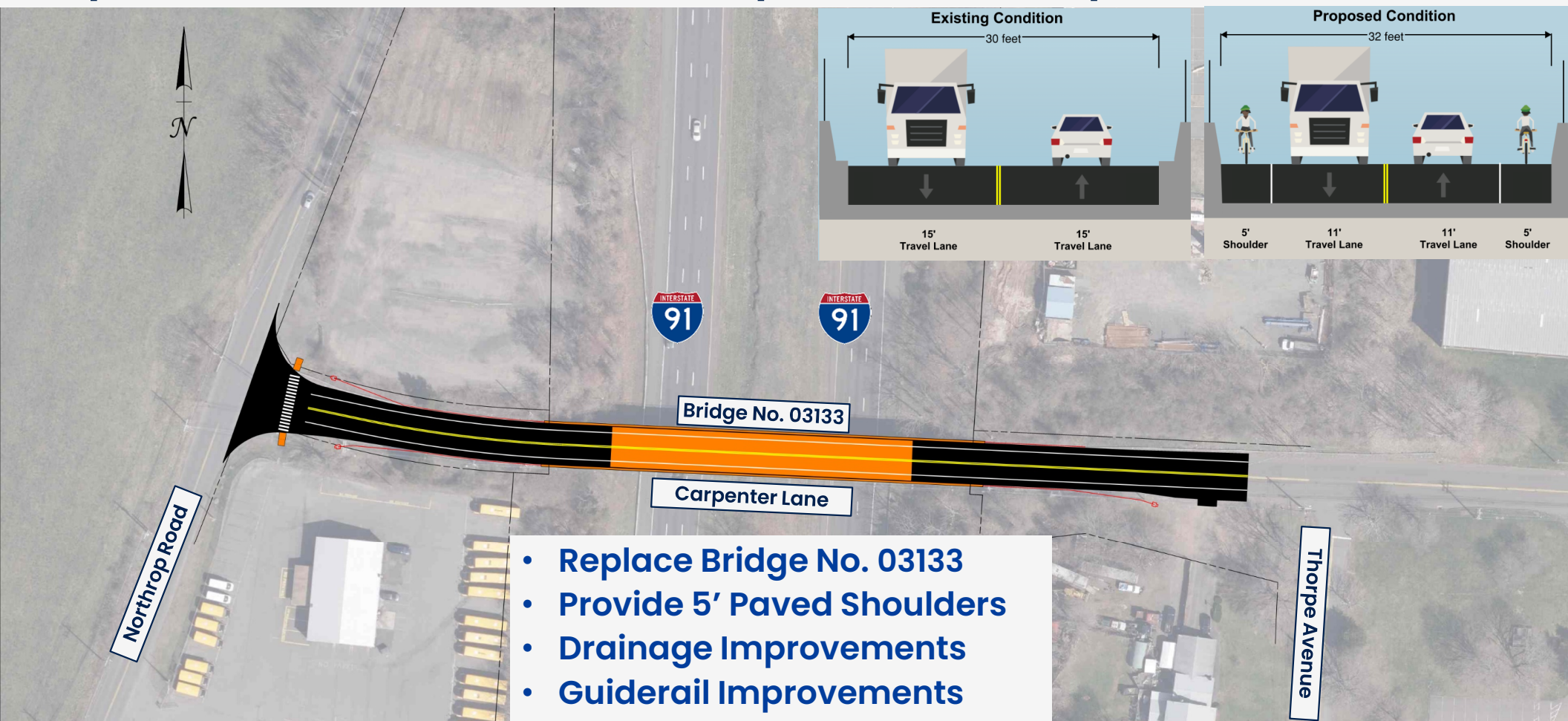

Proposed Base Technical Concept (BTC) – Carpenter Lane



Natural & Cultural Resources

- Northern Long-eared Bat (endangered), Tricolored Bat (proposed endangered), and Monarch Butterfly (threatened)
 - Consultation Completed – Not Likely to Adversely Affect.
- No regulated resources identified within the project area
- State Historic Preservation Office (SHPO) Section 106 Coordination Completed
 - No Adverse Effect determination received.
- Tribal Historic Preservation Office (THPO) Section 106 Consultation Completed
 - No Adverse Effect determination received.

Allow Full Bridge Closure with Detour

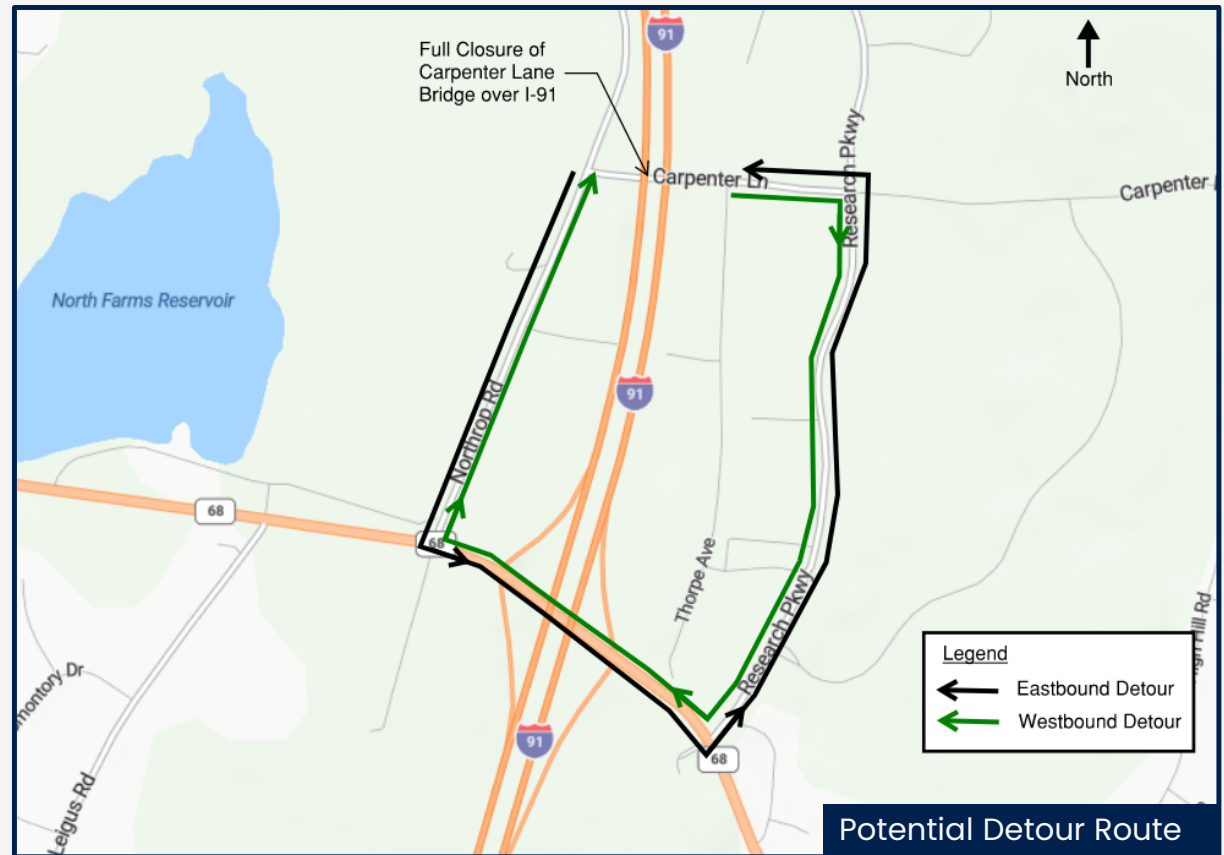
- Coordination with closure of either New Rock Hill Road or Durham Road

Utilities

- Attached to the Bridge
 - Wallingford Water Division (water main)
 - Frontier Communications
- Utility Pole Relocations
 - Wallingford Electric
 - Frontier Communications
- In-Progress
 - Coordination with other telecommunication and gas utilities is on-going

Rights-of-Way

- Minor property impacts are anticipated along Carpenter Lane

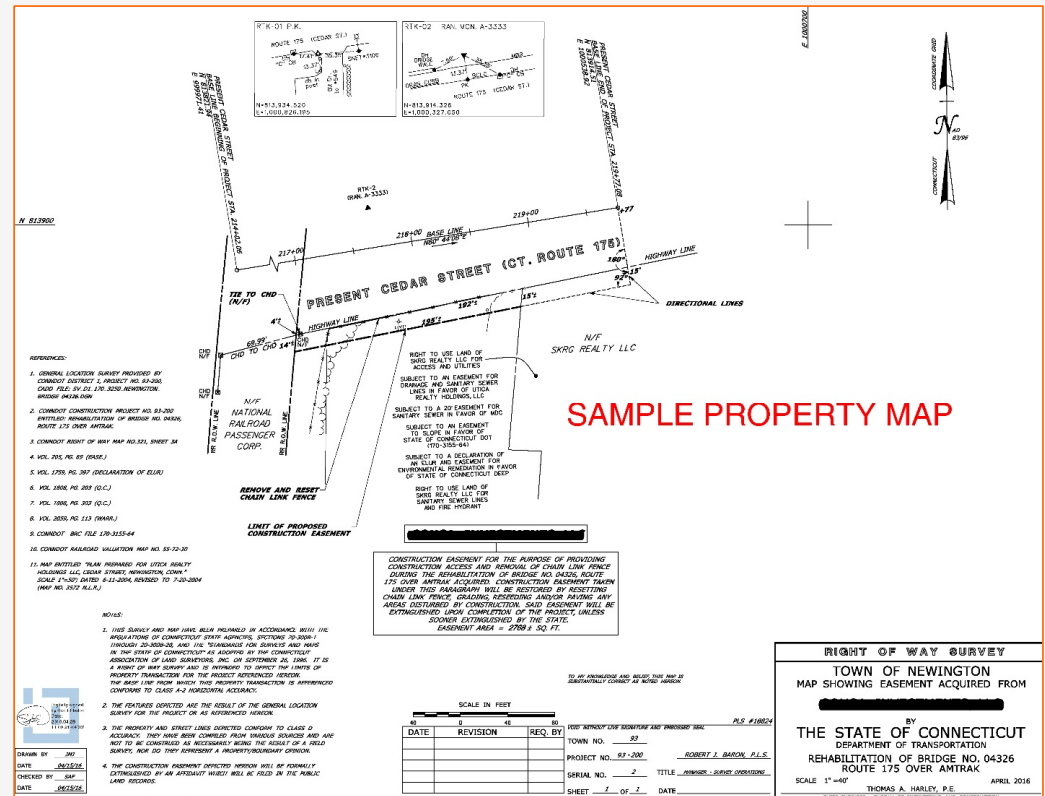

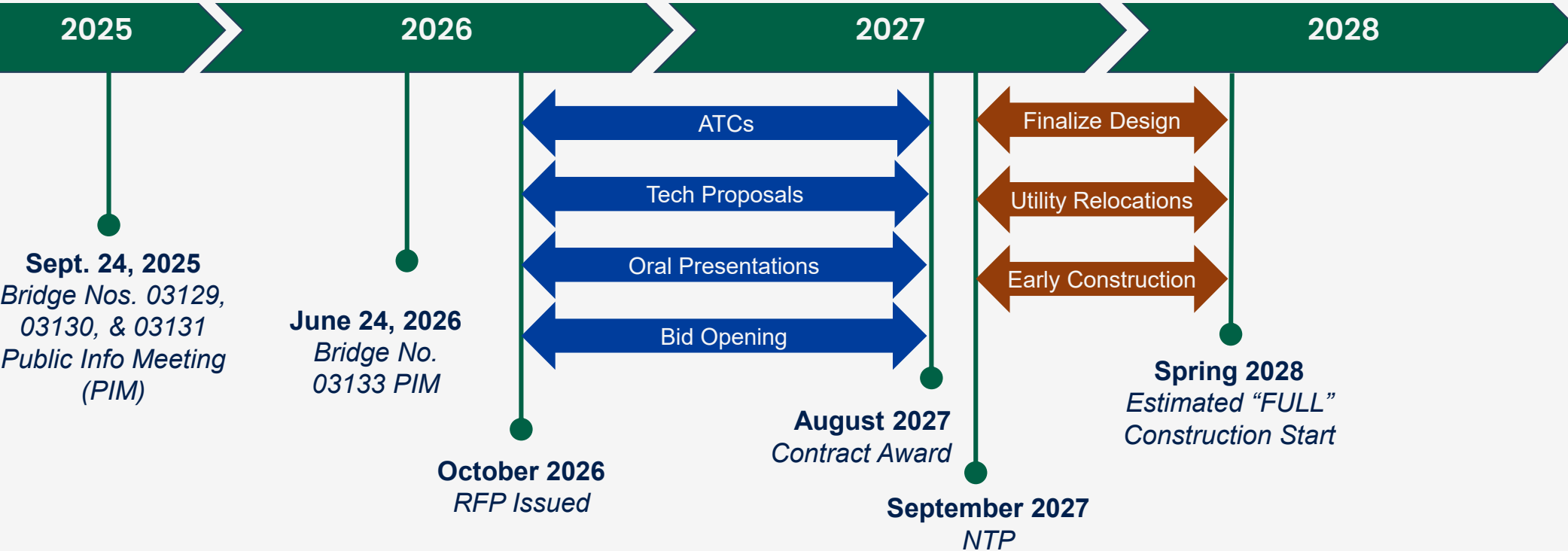

Project Schedule & Construction Costs



Estimated Construction Costs

- Between \$60 and \$90 million
- Anticipated 80% federal funds and 20% state funds

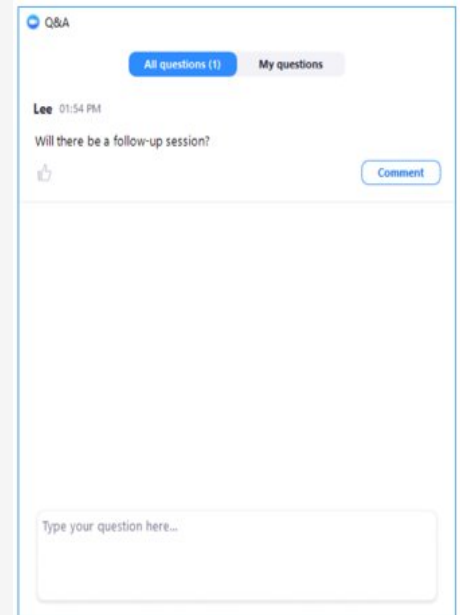
