INTRODUCTION

On August 24, 2023, Eli Rada, owner of Premier Limousine/Tel Aviv Limousine, Inc. dba Compo Limo, requested to increase the passenger capacity of his motor vehicles in general livery service from ten (10) passengers or less to fourteen (14) passengers or less. Felipe Briseno, Staff Attorney III, approved his request.

Furthermore, when writing this final decision, it came to our attention that this company also has interstate livery authority that was not included in their last final decision. It is being added back into this final decision. Therefore, livery permit number 2494 is hereby amended and reissued in the following form:

LIVERY PERMIT NUMBER 2494

FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Premier Limousine/Tel Aviv Limousine, Inc. dba Compo Limo is hereby permitted and authorized to operate eleven (11) motor vehicles, each having a seating capacity of fourteen (14) passengers or less, in general livery service from a headquarters in Westport.

Furthermore, Premier Limousine/Tel Aviv Limousine, Inc. dba Compo Limo is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-220392-C.

This permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 1806-AVWO-84-L, the authority granted herein will be revoked.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**
