I. APPLICANT'S PROPOSAL

By application 2306-TH-98-L filed on June 21, 2023, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), Executive 2000 Transportation, LLC dba Executive 2000 Limo (hereinafter "applicant"), holder of Livery Permit Number 2820, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its headquarters from Cromwell to Middletown, and close the Cromwell headquarters. Specifically, to transfer:

1. Five (5) motor vehicles with a passenger capacity of ten (10) adults or less in general livery service.
2. Eighteen (18) motor vehicles, each having a seating capacity of less than ten (10) adults or less in durational livery service under contract with Veyo, LLC.
3. Motor vehicles in the transportation of passengers in charter and special operations in interstate commerce under such authorization as issued or amended by the Federal Highway Administration in the issuance of Certificate Number MC-3872371-C.

II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

III. FINDINGS OF FACT

1. The applicant has submitted the proper application before this Department.
2. The Department finds that the applicant's records indicate two (2) of its twenty-three (23) vehicles have been in use and are available for transfer.
4. No opposition was filed by existing operators in the headquarters town.
5. On July 12, 2023, Joyful Selah, owner, voluntarily revoked her Federal Highway Administration authority due to MC-3872371-C inactive without insurance.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to Sections 13b-102 and 13b-103, the instant application, given Application Number 2306-TH-98-L, filed by Executive 2000 Transportation, LLC dba Executive 2000 Limo, is approved and Livery Permit Number 2820 is amended and reissued as follows:

LIVERY PERMIT NUMBER 2820
FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Executive 2000 Transportation, LLC dba Executive 2000 Limo is hereby permitted to operate FIVE (5) motor vehicles, each having a seating capacity of ten (10) adults or less in general livery service to all points in Connecticut from a headquarters in Middletown, Connecticut.

DURATIONAL LIVERY SERVICE
UNDER CONTRACT WITH VEYO, LLC
DOCKET NO. 0102-NGOV-09-L – GRANTED JULY 5, 2001

Executive 2000 Transportation, LLC dba Executive 2000 Limo is authorized to operate THREE (3) motor vehicles, each having a seating capacity of less than ten (10) adults, under contract with Veyo, LLC, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Middletown, Connecticut.

DURATIONAL LIVERY SERVICE
UNDER CONTRACT WITH VEYO, LLC
DOCKET NO. 0807-NGOV-121-L – GRANTED JANUARY 29, 2009

Executive 2000 Transportation, LLC dba Executive 2000 Limo is authorized to operate SIX (6) motor vehicles, each having a seating capacity of less than ten (10) adults, under contract with Veyo, LLC, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Middletown, Connecticut.

DURATIONAL LIVERY SERVICE
UNDER CONTRACT WITH VEYO, LLC
DOCKET NO. 1102-GOV-4-L – GRANTED AUGUST 17, 2011

Executive 2000 Transportation, LLC dba Executive 2000 Limo is authorized to operate TWO (2) motor vehicles, each having a seating capacity of less than ten (10) adults, under contract with Veyo, LLC, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Middletown, Connecticut.

DURATIONAL LIVERY SERVICE
UNDER CONTRACT WITH VEYO, LLC
DOCKET NO. 1107-GOV-77-L – GRANTED FEBRUARY 2, 2012

Executive 2000 Transportation, LLC dba Executive 2000 Limo is authorized to operate SEVEN (7) motor vehicles, each having a seating capacity of less than ten (10) adults, under contract with Veyo, LLC, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Middletown, Connecticut.

RESTRICTIONS:

The additional authority granted in Dockets No. 0102-NGOV-09-L, 0807-NGOV-121-L, 1102-GOV-4-L, and 1107-GOV-77-L shall be durational in nature and shall exist only for the period of time that the permit holder has a current and continuing contract in effect for the provision of service with Veyo, LLC.

The permit holder shall notify the department of any termination of its contract with Veyo, LLC or the cessation of the active provision of service there under. The permit holder shall file with the department on an annual basis, upon registration or re-registration of the motor vehicle authorized in this decision a current executed copy of the extension of said contract. Failure to file an extension of the contract or a new executed contract with Veyo, LLC shall void the authority for the vehicles authorized pursuant to this contract.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.
