INTRODUCTION

By application filed on August 9th, 2023 with the Department of Transportation (hereinafter “department”), pursuant to Section 13b-94a of the Connecticut General Statutes, as amended, Judes Joseph DBA Prestige ProLIMO (hereinafter “applicant”) with a mailing address of 161 Kings Highway East, Suite 206, Fairfield, CT 06825 seeks approval to register its Federal Motor Carrier Safety Administration authority for Interstate charter bus operations, as authorized and contained in Certificate No. MC- 00173318 issued on June 22nd, 2023.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Sections 13b-88, 13b-89, and 13b-94a, and Interstate Charter Bus Permit No. 589 is issued to Judes Joseph DBA Prestige ProLIMO in the following form:

Judes Joseph DBA Prestige ProLIMO is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter bus operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate No. MC-00173318

This permit shall remain in effect until it is amended, suspended, or revoked by the department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the department. **Vehicles authorized herein must be registered within sixty (30) days of the date of this decision.**

A memorandum of the permit bearing the seal of the department shall be kept conspicuously posted in the motor vehicles operated hereunder.
