I. INTRODUCTION

Capitol Moving and Storage Co., Inc (hereinafter “transferor”) is the holder of Certificate No. HG514 last issued by the Department of Transportation (hereinafter “Department”) on September 30, 1988, authorizing, subject to such regulations and conditions as the Department may from time to time prescribe, to transport property for hire as a motor common carrier over irregular routes as follows: Household goods within the State of Connecticut, between all points upon calls received at its headquarters in Hartford.

II. APPLICANTS' PROPOSAL

By joint application filed on July 27, 2023, given Docket No. 2307-S-106-HG, the applicants seek Department approval of the sale and transfer of the authority, granted under Certificate No. HG514, from the transferor to Capitol Services Group LLC dba Capitol Relocation & Logistics, (hereinafter “applicant”).

III. FINDINGS OF FACT

1. After a review of the transferor's records, it was determined that the transferor had bills of lading.
2. The transferee's financial statement indicates it is financially able to staff, equip and operate the household goods moving service transferred herein.
3. The required Connecticut State Police Criminal History Information Report, indicating the absence of any criminal records of the transferee, was filed with the application.
4. The order in the final decision for docket number 2303-C-47-HG mandated that the transferor file an application for the sale of a household goods carrier certificate.
5. A review of the transferor’s records shows that a memo was issued to the department stating that the headquarters was moved from Hartford to South Windsor. The memo, dated April 6, 1999, was accepted as an acceptable document to change the certificate headquarters.
6. A copy of the purchase agreement was submitted with this application.

IV. CONCLUSION

Therefore, based upon the facts stated above, and pursuant to Section 13b-406, the Department hereby approves the sale and transfer of the authority granted under Certificate No. HG514 as proposed, to the transferee, Capitol Services Group LLC dba Capitol Relocation & Logistics. Following the approval of this sale and transfer, the transferor will retain no rights to the authority transferred and Certificate No. HG514 is hereby amended and reissued in the following form:

Capitol Services Group LLC dba Capitol Relocation & Logistics is hereby permitted and authorized, subject to such regulations and conditions as the department may from time to time prescribe, to transport property for hire as a motor common carrier over irregular routes as follows:

Household goods within the State of Connecticut, between all points upon calls received at its headquarters in South Windsor.

The certificate holder must accept and transport property, as herein authorized in accordance with its tariff on file, for all persons who desire the service to the extent of the certificate holder's facilities at uniform rate for all similar service.

There shall be carried in each vehicle operated under this authority a copy of the certificate registration receipt by the Department.

The certificate shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the certificate holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State statutes and/or rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend or revoke this certificate.

This certificate may not be sold or transferred until it has been operational for more than twenty-four (24) months. This certificate is transferrable only with the approval of the Department and is issued subject to compliance by the holder thereof with all motor vehicle laws of the State of Connecticut and with such rules, regulations, and orders as this Department may from time to time prescribe.

A memorandum of this certificate, bearing the seal of the Department, shall be kept conspicuously posted in the motor vehicle operated hereunder.
