#### I. INTRODUCTION

#### A. Applicant's Proposal

By application filed on August 24, 2023, pursuant to Section 13b-389 of the Connecticut General Statutes and assigned Docket No. 2308-N-123-HG, Bubba's Moving LLC ("hereinafter applicant"), with a mailing address of 38 Sillwold Drive, Wethersfield, CT 06109 seeks authorization from the Connecticut Department of Transportation (hereinafter "department") to operate motor vehicles in the transportation of household goods for hire, as a household goods carrier, over irregular routes between all points in Connecticut from a headquarters in Wethersfield.

#### B. Hearing

Pursuant to Connecticut General Statutes Section 13b-391, a hearing is not required for this application.

Notice of the application was given to the applicant and to other interested parties in the municipality of Wethersfield on August 24, 2023, requesting comments on the application.

#### II. FINDING OF FACT

- 1. The applicant is seeking to operate an intrastate household goods moving company from a headquarters in Wethersfield.
  - 2. Bryan Healy plans to haul his own commodities and deliver them to his customers.
  - 3. The applicant has a balance of \$25,947.05 in its business bank account.
  - 4. The applicant will be operating a rental vehicle that he is contracted with from Penske Truck Leasing in the moving business.
  - 5. The applicant's first six months of expenses include vehicle rental cost of \$16,921.41, advertising cost of \$480.00.
  - 6. Bryan Healy will be operating the company himself.
  - 7. Bryan Healy has a clean criminal record.
  - 8. There was no opposition to a grant of this application.

#### III. DEPARTMENT ANALYSIS AND CONCLUSIONS OF LAW

The Department of Transportation has jurisdiction over any person operating any motor vehicle in the transportation of household goods for hire as a household goods carrier pursuant to Section 13b-389 of the Connecticut General Statutes. Further, no person shall operate as a household goods carrier, within Connecticut, without first obtaining a certificate of public convenience and necessity to so operate.

In determining whether such a certificate shall be granted, the Commissioner of Transportation shall take into consideration the existing motor transportation facilities and the effect upon them of granting such a certificate, the suitability of the applicant, the financial responsibility of the applicant, the ability of the applicant to efficiently perform the service for which the authority is requested, and the criminal history of the applicant pursuant to Section 13b-392 of the Connecticut General Statues.

As far as the applicant's financial ability is concerned, the applicant presented evidence of vehicle rental costs of \$16,921.41 and advertising costs of \$480.00. The applicant has \$25,947.05 in a business bank account which is sufficient to cover these costs thereby making the applicant financially suitable.

The applicant submitted a criminal record check for Bryan Healy which showed no criminal record. Based on the evidence presented, the applicant is suitable to handle this proposed operation.

Another factor to be considered is the ability of the applicant to efficiently perform the service for which the authority is requested. The applicant plans to utilize a vehicle that he is leasing from Penske Truck Leasing for the business. The one leased vehicle will enable efficient performance of duties.

The last criterion to be considered is the effect on the existing motor carrier facilities by granting this certificate. No moving companies have opposed the application indicating that there would be little, if any, effect on the operators in that area.

Based on the evidence provided, the applicant has proven all the necessary elements to be granted a certificate to operate a household goods moving company from a headquarters in Wethersfield.

#### IV. ORDER

Based upon the above and pursuant to Section 13b-391 of the Connecticut General Statutes, the application of Bubba's Moving LLC is hereby granted, and Certificate Number HG1828 is issued as follows:

# CERTIFICATE NUMBER HG1828 TO OPERATE MOTOR VEHICLES FOR THE TRANSPORTATION OF PROPERTY FOR HIRE AS A MOTOR COMMON CARRIER

Bubba's Moving LLC is hereby permitted and authorized, subject to such regulations and conditions as the department may from time to time prescribe, to transport property for hire as a motor common carrier over irregular routes as follows:

Household goods, within the State of Connecticut, between all points upon calls received at its headquarters in Wethersfield.

The certificate holder must accept and transport property, as herein authorized in accordance with its tariff on file, for all persons who desire the service to the extent of the certificate holder's facilities at uniform rates for all similar service.

#### **CONDITIONS:**

A motor vehicle must be registered and insured under this certificate within ninety (90) days from the date of this decision. Failure to so may result in a revocation of authority.

There shall be carried in each vehicle operated under this authority a copy of the certificate of registration receipt issued by the department.

The certificate shall remain in effect until suspended, amended or revoked by the department. Failure of the certificate holder to maintain proper insurance or to comply with all motor vehicle laws and other pertinent state statutes and/or the rules, regulations and orders of the department shall be considered sufficient cause to revoke said certificate.

This certificate may not be sold or transferred until it has been operational for more than twenty-four (24) months.

This certificate is transferable only with the approval of the department and is issued subject to compliance by the holder thereof with all motor vehicle laws of the State of Connecticut, and with such regulations and orders as this department may from time to time prescribe.
