**AUTHORITY FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES IN INTRASTATE  
CHARTER BUS TRANSPORTATION**

**INTRODUCTION**

By application, given Application Number 2403-N-27-B, filed on March 21, 2024, with the Department of Transportation (hereinafter "department"), pursuant to Section 13b-94a of the Connecticut General Statutes, as amended, Dunbar Patient Transport Corporation (hereinafter "applicant") with a mailing address of 959 Main Street, Suite 108, Stratford, CT 06615 seeks approval to operate bus type motor vehicles in intrastate charter bus transportation between all points in Connecticut from a headquarters in Stratford.

After consideration by the department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-94a, and Bus Permit Number 592 is issued to Dunbar Patient Transport Corporation in the following form:

**BUS PERMIT NUMBER 592**

**FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES IN INTRASTATE CHARTER  
BUS TRANSPORTATION**

Dunbar Patient Transport Corporation is permitted and authorized to operate bus type motor vehicles in intrastate charter bus transportation in accordance with the Connecticut General Statutes, Section 13b-94a, between all points in Connecticut from a headquarters in Stratford.

This permit shall remain in effect until it is amended, suspended, or revoked by the department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**

A memorandum of the permit bearing the seal of the department shall be kept conspicuously posted in the motor vehicles operated hereunder.
