I. APPLICANT'S PROPOSAL

By application 2404-TH-40-L filed on April 23rd, 2024, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), Diligent Service Providers, LLC DBA D.S.P. Transportation (hereinafter "applicant"), holder of Livery Permit Number 3669, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its New Britain headquarters to Meriden and to close the New Britain headquarters. This includes the transfer of the following vehicles:

1. Two (2) motor vehicles, each having a seating capacity of less than eleven (11) passengers in general livery service.

II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

III. FINDINGS OF FACT

1. The applicant has submitted the proper application before this Department.
2. The Department finds that the applicant's records indicate all its vehicles have been in use and are available for transfer.
3. No opposition was filed by existing operators in the headquarters town.

IV. CONCLUSION AND ORDER

Based on the above and pursuant to Sections 13b-102 and 13b-103, the instant application, given Application Number 2404-TH-40-L, filed by Diligent Service Providers, LLC DBA D.S.P. Transportation, is approved and Livery Permit Number 3669 is amended and reissued as follows:

LIVERY PERMIT NUMBER 3669 **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Diligent Service Providers, LLC dba D.S.P. Transportation is authorized to operate two (2) motor vehicles, each having a seating capacity of less than eleven (11) passengers, in general livery service to all points in Connecticut from a headquarters in Meriden.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke said permit. This permit is transferrable only with the approval of the Department.
