**AUTHORITY FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES**  
**IN INTRASTATE CHARTER BUS TRANSPORTATION**

**INTRODUCTION**

By application filed on June 6, 2024, with the Department of Transportation (hereinafter “department”), pursuant to Section 13b-94a of the Connecticut General Statutes, as amended, Smooth Line Limousine and Transportation, LLC dba Smooth Line Limo (hereinafter “applicant”) with a mailing address of 1019 Farmington Avenue, Suite 3, Bristol, CT 06010, seeks approval to operate bus type motor vehicles in intrastate charter bus transportation between all points in Connecticut from a headquarters in Bristol.

After consideration by the department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-94a, and Bus Permit Number 593 is issued to Smooth Line Limousine and Transportation, LLC dba Smooth Line Limo in the following form:

**BUS PERMIT NUMBER 593**  
**FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES IN**  
**BOTH INTRASTATE AND INTERSTATE CHARTER BUS TRANSPORTATION**

Smooth Line Limousine and Transportation, LLC dba Smooth Line Limo is permitted and authorized to operate bus type motor vehicles in intrastate charter bus transportation in accordance with the Connecticut General Statutes, Section 13b-94a, between all points in Connecticut from a headquarters in Bristol.

This permit shall remain in effect until it is amended, suspended, or revoked by the department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**
