APPLICATION OF LASSE'S LIVERY SERVICE INC., HOLDER OF LIVERY PERMIT NO. 92, TO TRANSFER HEADQUARTERS FROM STRATFORD TO MILFORD

### I. <u>APPLICANT'S PROPOSAL</u>

By application 2406-TH-57-L filed on June 11, 2024, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), Lasse's Livery Service Inc. (hereinafter "applicant"), holder of Livery Permit Number 92, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its Stratford headquarters to Milford, and close the Stratford headquarters. Specifically, to transfer:

- 1. Eight (8) motor vehicles in Special Livery Service, each having a passenger seating capacity of ten (10) adults or less. Special Livery Service is limited to funerals, weddings, christenings, public processions, and celebrations.
- 2. Six (6) motor vehicles in General Livery Service, each having a passenger seating capacity of ten (10) adults or less.
- 3. On August 5, 2024, Mr. Gregory Archer, Vice President of Lasse's Livery Service, Inc., emailed the Regulatory and Compliance Unit to request the voluntary surrender of their interstate livery authority.

#### II. <u>DEPARTMENT ANALYSIS</u>

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

#### III. FINDINGS OF FACT

- 1. The applicant has submitted the proper application before this Department.
- 2. The Department finds that the applicant's records indicate all its authorized vehicles have been in use and are available for transfer.
- 3. No opposition was filed by existing operators in the headquarters town.
- 4. The Department has no objection to the permit holder voluntarily surrendering its interstate livery authority. The forfeiture of this authority will be reflected when the permit is amended and reissued.

#### IV. CONCLUSION AND ORDER

Based on the above and pursuant to Sections 13b-102 and 13b-103, the instant application, given Application Number 2406-TH-57-L, filed by Lasse's Livery Service Inc., is approved and Livery Permit Number 92 is amended and reissued as follows:

## LIVERY PERMIT NUMBER 92 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Lasse's Livery Service, Inc. is hereby permitted and authorized, in accordance with and under the provisions of the Connecticut General Statutes, as amended, to operate the following from a headquarters in Milford:

- 1. EIGHT (8) motor vehicles in Special Livery Service, each having a passenger seating capacity of ten (10) adults or less. Special Livery Service is limited to funerals, weddings, christenings, public processions, and celebrations.
- 2. SIX (6) motor vehicles in General Livery Service, each having a passenger seating capacity of ten (10) adults or less.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department.
