## I. INTRODUCTION

By application 2408-AVWO-75-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on August 5, 2024, American Rides Livery Service, LLC (hereinafter "applicant") made application for two (2) additional motor vehicles in general livery service to all points in Connecticut from a headquarters in Plainfield under the provisions of Connecticut General Statutes, Section 13b-103(a)(4).

The applicant, holder of Livery Permit Number 3670, is currently permitted and authorized to operate fourteen (14) motor vehicles, each having a seating capacity of ten (10) passengers or less, in general livery service to all points in Connecticut from a headquarters in Plainfield.

## II. DEPARTMENT ANALYSIS

1. The applicant has submitted the proper application before the Department.
2. The Department awarded this applicant's permit two (2) additional vehicles on February 15, 2024 per Final Decision, application 2401-AVWO-7-L. The applicant is eligible to apply for two (2) additional vehicles during this calendar year.
3. Department records indicate that all the existing vehicle(s) authorized are registered and in use.
4. Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

## III. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103(a)(4), the application is hereby approved and therefore Livery Permit Number 3670 is amended and reissued as follows:

### **LIVERY PERMIT NUMBER 3670** **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

American Rides Livery Service, LLC is hereby permitted and authorized to operate SIXTEEN (16) motor vehicles, each having a seating capacity of ten (10) passengers or less, in general livery service to all points in Connecticut from a headquarters in Plainfield.

This permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 2408-AVWO-75-L, the authority granted herein will be revoked.

This permit shall remain in effect until it is amended, suspended or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.**
