## I. APPLICANT'S PROPOSAL

By application 2412-TH-101-L filed on December 2, 2024, pursuant to Section 13b-103 of the Connecticut General Statutes (CGS), Avon Transportation, LLC (hereinafter "applicant"), holder of Livery Permit Number 3366, seeks authorization from the Connecticut Department of Transportation (hereinafter "Department"), to transfer its Simsbury headquarters to New Britain, and close the Simsbury headquarters. Specifically, to transfer:

1. Four (4) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service.
2. Avon Transportation, LLC is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-832633-C.

## II. DEPARTMENT ANALYSIS

A legal notice was mailed to registered livery companies in the headquarters towns and towns contiguous to its headquarters town and was not opposed within the thirty (30) days as allowed by statute. The Department's staff has analyzed the evidence presented in this instant application and finds that it should be granted without a hearing.

## III. FINDINGS OF FACT

1. The applicant has submitted the proper application before this Department.
3. The Department finds that one (1) of the four (4) authorized vehicles is currently registered, however, all four (4) authorized vehicles are available for transfer.
3. No opposition was filed by existing operators in the headquarters town.

## IV. CONCLUSION AND ORDER

Based on the above and pursuant to Sections 13b-102 and 13b-103, the instant application, given Application Number 2412-TH-101-L, filed by Avon Transportation, LLC, is approved and Livery Permit Number 3366 is amended and reissued as follows:

### **LIVERY PERMIT NUMBER 3366** **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Avon Transportation, LLC is hereby permitted and authorized, in accordance with and under the provisions of General Statutes, as amended, to operate four (4) motor vehicles, each having a passenger seating capacity of ten (10) adults or less, in general livery service between all points in Connecticut from a headquarters in New Britain.

Avon Transportation, LLC is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-832633-C.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**
