I. INTRODUCTION

By application 2501-AVWO-15-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on January 29, 2025, Essex Limousine Service, Inc (hereinafter "applicant") made application for two (2) additional motor vehicles in general livery service from a headquarters in Essex under the provisions of Connecticut General Statutes, Section 13b-103(a)(4).

The applicant, holder of Livery Permit Number 2389, is currently permitted and authorized to operate:

1. Eight (8) motor vehicles, each having a seating capacity of ten (10) adults or less in General Livery Service between all points in Connecticut from a headquarters in Essex.
2. Essex Limousine Service, Inc. is also permitted and authorized to operate bus type motor vehicles having a seating capacity of more than ten (10) but less than thirty-five (35) adults in General Livery Service between all points in Connecticut from a headquarters in Essex.
3. Essex Limousine Service, Inc. is further permitted and authorized to operate motor vehicles in the transportation of passengers in charter and special operations in interstate commerce under such authorization as issued or amended by the Federal Highway Administration in the issuance of Certificate Number MC204279.
4. Essex Limousine Service, Inc. is also permitted and authorized to operate three (3) motor vehicles, each having a seating capacity of ten (10) adults or less, under contract with Medical Transportation Management, Inc. dba Veyo, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Essex.

II. DEPARTMENT ANALYSIS

1. The applicant has submitted the proper application before the Department.
2. It has been at least one calendar year since the applicant last applied for additional vehicles.
3. Department records indicate that all the existing vehicles authorized are registered and in use.
4. Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

III. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103(a), the application is hereby approved and therefore Livery Permit Number 2389 is amended and reissued as follows:

LIVERY PERMIT NUMBER 2389 **FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Essex Limousine Service, Inc. is hereby permitted and authorized to operate TEN (10) motor vehicles, each having a seating capacity of ten (10) adults or less in General Livery Service between all points in Connecticut from a headquarters in Essex.

Essex Limousine Service, Inc. is also permitted and authorized to operate bus type motor vehicles having a seating capacity of more than ten (10) but less than thirty-five (35) adults in General Livery Service between all points in Connecticut from a headquarters in Essex.

Essex Limousine Service, Inc. is further permitted and authorized to operate motor vehicles in the transportation of passengers in charter and special operations in interstate commerce under such authorization as issued or amended by the Federal Highway Administration in the issuance of Certificate Number MC204279.

RESTRICTIONS:

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the Permit holder to maintain proper insurance and/or comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations and orders of the Department shall be considered sufficient cause to amend, suspend, or revoke this permit.

This permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final decision. If at any time during the twenty-four (24) month period the applicant enters into a contract for sale and transfer of any of the vehicles authorized under application 2501-AVWO-15-L, the authority granted herein will be revoked.

**DURATIONAL LIVERY SERVICE
UNDER CONTRACT WITH MEDICAL TRANSPORTATION MANAGEMENT, INC. DBA VEYO
DOCKET NO. 0005-GOV-66-L GRANTED JANUARY 17, 2001**

Essex Limousine Service, Inc. is authorized to operate three (3) motor vehicles, each having a seating capacity of ten (10) adults or less, under contract with Medical Transportation Management, Inc. dba Veyo, for the provision of livery service under contract with a federal, state, or municipal agency or a lower tier contract thereof from a headquarters in Essex.

RESTRICTIONS:

The authorization granted in Docket Number 0005-GOV-66-L shall be durational in nature and shall exist only for the period of time that the permit holder has continuing contracts in effect for the provision of service with Medical Transportation Management, Inc dba Veyo.

The permit holder shall notify the department of any termination of these contracts of the cessation of active provision of service under them. The Permit holder shall file with the department, on an annual basis, upon registration or re-registration of the motor vehicles authorized in this final decision, a current copy of the extension of said contract. Failure to file an extension of the contract or a new contract shall void the authority for all vehicles granted pursuant to said contracts.

This permit is not transferable and shall remain in effect until revoked by the department or the contract under which this authority is granted has expired. Failure of the Permit Holder to maintain proper insurance and/or comply with all the pertinent motor vehicle laws and other State statutes and/or the rules and regulations and orders of the department shall be considered sufficient cause to revoke or suspend said Permit.
