APPLICATION NUMBER 2501-I-3-L REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION AUTHORITY

By application 2501-I-3-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on January 7, 2025, CT Craft Beer Tours, LLC (hereinafter "applicant"), seeks approval to register their Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-1688467-C, issued on December 11, 2024. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

CT Craft Beer Tours, LLC currently has authority to operate one (1) motor vehicle, having a seating capacity of eleven (11) passengers, in general livery service to all points in Connecticut from a headquarters in Mansfield.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3695 is revised and reissued to in the following form:

LIVERY PERMIT NUMBER 3695 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

CT Craft Beer Tours, LLC is permitted and authorized to operate one (1) motor vehicle, having a seating capacity of eleven (11) passengers, in general livery service to all points in Connecticut from a headquarters in Mansfield.

Furthermore, CT Craft Beer Tours, LLC is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC-1688467-C.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.
