APPLICATION OF JAQUAR LIMO LLC DBA JAGUAR LIMO, HOLDER OF PERMIT 3382, TO OPERATE TWO (2) ADDITIONAL MOTOR VEHICLES IN GENERAL LIVERY SERVICE FROM A HEADQUARTERS IN WINDSOR LOCKS WITHOUT A HEARING.

FINAL DECISION

April 8, 2025

I. INTRODUCTION

By application 2504-AVWO-36-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on April 1, 2025, Jaquar Limo LLC dba Jaguar Limo (hereinafter "applicant") made application for two (2) additional motor vehicles in general livery service from a headquarters in Windsor Locks under the provisions of Connecticut General Statutes, Section 13b-103(a)(4).

The applicant, holder of Livery Permit Number 3382, is currently permitted and authorized to operate twenty-five (25) motor vehicles, each having a seating capacity of less than eleven (11) passengers in general livery service from a headquarters in Windsor Locks.

Jaquar Limo LLC dba Jaguar Limo is also permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Safety Administration in the issuance of certificate number MC-857155.

II. DEPARTMENT ANALYSIS

- 1. The applicant has submitted the proper application before the Department.
- 2. The Department awarded this permit two (2) additional vehicles on March 4, 2025. This applicant is eligible to apply for two (2) additional vehicles during this calendar year.
- 3. Department records indicate that all the existing vehicles authorized are registered and in use.
- 4. Department records further indicate that there are no outstanding violations or matters pending adjudication against the applicant.

III. CONCLUSION AND ORDER

Based on the above and pursuant to Section 13b-103(a)(4), the application is hereby approved and therefore Livery Permit Number 3382 is amended and reissued as follows:

LIVERY PERMIT NUMBER 3382 FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE

Jaquar Limo LLC dba Jaguar Limo is hereby permitted and authorized to operate TWENTY-SEVEN (27) motor vehicles, each having a seating capacity of less than eleven (11) passengers in general livery service from a headquarters in Windsor Locks

Jaquar Limo LLC dba Jaguar Limo is further permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Safety Administration in the issuance of certificate number MC-857155.

This permit may not be sold or transferred until it has been operational, i.e., a vehicle registered with livery plates thereunder, for not less than twenty-four (24) consecutive months from the date of this final

decision. If at any time during the twenty-four (24) month period the applicant enters a contract for sale and transfer of any of the vehicles authorized under application 2504-AVWO-36-L, the authority granted herein will be revoked.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. Vehicles authorized herein must be registered within thirty (30) days of the date of this decision.
