**REGISTRATION OF FEDERAL MOTOR CARRIER SAFETY ADMINISTRATION**  
**AUTHORITY**

By application 2505-I-50-L, filed with the Connecticut Department of Transportation (hereinafter "Department") on May 13th, 2025, Trust In Us Transportation LLC (hereinafter "applicant"), seeks approval to register their Federal Motor Carrier Safety Administration authority, as authorized and contained in certificate number MC-01709575, issued on April 28, 2025. The applicant submitted the requisite Criminal Conviction Information Report, conducted in accordance with Section 29-17a of the Connecticut General Statutes.

Trust In Us Transportation LLC currently has authority to operate one (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in general livery service to all points in Connecticut from a headquarters in Sprague.

After consideration by the Department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-102(b), and Livery Permit Number 3828 is revised and reissued in the following form:

**LIVERY PERMIT NUMBER 3828**  
**FOR THE OPERATION OF MOTOR VEHICLES IN LIVERY SERVICE**

Trust In Us Transportation LLC is permitted and authorized to operate one (1) motor vehicle, having a seating capacity of less than eleven (11) passengers, in general livery service to all points in Connecticut from a headquarters in Sprague.

Furthermore, Trust In Us Transportation LLC is permitted and authorized to operate motor vehicles as a common carrier of passengers, in charter and special operations, in interstate commerce under such authorization as issued or amended by the Federal Motor Carrier Safety Administration in the issuance of Certificate Number MC- 01709575.

This permit shall remain in effect until it is amended, suspended, or revoked by the Department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/ or the rules, regulations, and orders of the Department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the Department. **Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.**
