INTRODUCTION

By application, given Application Number 2505-N-49-B, filed on May 13, 2025, with the Department of Transportation (hereinafter “department”), pursuant to Section 13b-94a of the Connecticut General Statutes, as amended, The Mary Wade Home, Inc. (hereinafter “applicant”) with a mailing address of 118 Clinton Avenue, New Haven, CT 06513 seeks approval to operate bus type motor vehicles in intrastate charter bus transportation between all points in Connecticut from a headquarters in New Haven.

FINDINGS OF FACT

The Mary Wade Home, Inc. is a nonprofit organization with 501(c)3 status with the Internal Revenue Service. The principals listed on the business filing with the Secretary of State are members of the volunteer board of trustees. David Hunter, President and CEO, is the only person on the business filing who receives a salary. The members of the board of trustees are all volunteers who meet once a month and have set terms that require them to rotate off the nonprofit board. These trustees are strictly volunteers who have no duties or responsibilities with day-to-day operations. The three persons approved by this department to be responsible for the suitability of this permit and who have all submitted clean criminal record checks are as follows:

1. Kristin Butler: Chief Operating Officer
2. Patricia Scussel: Director of Home & Community-Based Services
3. David Slater: Transportation Coordinator

After consideration by the department, the instant application is hereby approved in accordance with Connecticut General Statutes, Section 13b-94a, and Bus Permit Number 597 is issued to The Mary Wade Home, Inc. in the following form:

BUS PERMIT NUMBER 597
FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES IN INTRASTATE CHARTER
BUS TRANSPORTATION

The Mary Wade Home, Inc. is permitted and authorized to operate bus type motor vehicles in intrastate charter bus transportation in accordance with the Connecticut General Statutes, Section 13b-94a, between all points in Connecticut from a headquarters in New Haven.

This permit shall remain in effect until it is amended, suspended, or revoked by the department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to

amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the department.
Vehicles authorized herein must be registered within sixty (60) days of the date of this decision.

CONDITIONS

The three people approved to be responsible for the suitability of this permit must submit to criminal record checks every three (3) years. The permit holder must notify the department of any change to the list provided. If a listed manager leaves the employment of the permit holder, the permit holder will have to provide the department with the replacement's name and title. This person would then be subject to the criminal history check requirement.
