**INTRODUCTION**

By application filed on June 12<sup>th</sup>, 2025, with the Department of Transportation (hereinafter “department”), Salter’s Express Company, Incorporated (hereinafter “applicant”) of 119 West Street, Simsbury, Connecticut 06070, seeks approval to register its Federal Motor Carrier Safety Administration authority, as authorized and contained in Certificate Number MC- 38650 issued on January 09<sup>th</sup>, 1981.

After consideration by the department, the instant application is hereby approved in accordance with Connecticut General Statutes, Sections 13b-88, 13b-89, and 13b-94a, and Interstate Charter Bus permit No. 596 is issued to Salter’s Express Company, Incorporated in the following form:

**BUS PERMIT NUMBER 596**  
**FOR THE OPERATION OF BUS TYPE MOTOR VEHICLES IN INTERSTATE CHARTER BUS**  
**TRANSPORTATION**

Salter’s Express Company, Incorporated is permitted and authorized to operate bus type motor vehicles as a common carrier of passengers in charter bus operations in interstate commerce, under such authorization as issued, or amended, by the Federal Motor Carrier Safety Administration in issuance of Certificate Number MC-38650.

This permit shall remain in effect until it is amended, suspended, or revoked by the department. Failure of the permit holder to maintain proper insurance and/or to comply with all pertinent motor vehicle laws and other State statutes and/or the rules, regulations, and orders of the department, shall be considered sufficient cause to amend, suspend, or revoke this permit. This permit is transferrable only with the approval of the department. **Vehicles authorized herein must be registered within thirty (60) days of the date of this decision.**
