Dear Providers,

The purpose of this communication is to provide guidance on COVID-19 vaccine ordering for the 2025-2026 season and outline the authorized products.

The Connecticut Department of Public Health (CT DPH) recommends the COVID-19 vaccine for the current season. Vaccination against COVID-19 remains the most effective defense to prevent severe COVID-19 disease outcomes. CT DPH strongly urges providers to discuss vaccination with patients and parents/guardians and to encourage COVID-19 vaccination based on risk and shared clinical decision making.

2025-2026 COVID-19 Vaccine Availability and Ordering

COVID-19 vaccines are now available to providers through the Connecticut Vaccine Program (CVP) for children 6 months through 18 years. Please submit orders via the Connecticut Immunization Information System (CT WiZ).

Doses have been released on allocation and additional stock will continue to become available throughout the season. Orders will be filled as supply allows.

Remember that you can order as often as needed during the course of the month, so providers are encouraged to order smaller quantities of COVID-19 vaccine based on clinic needs.

Restitution will *not* be required for COVID-19 vaccines if a provider is unable to utilize all doses prior to expiration.

Please review our <u>previous communication</u> for information on returning expired COVID-19 inventory as well as guidance for pharmacy staff and information on insurance coverage.

The following 2025-2026 vaccines received Food and Drug Administration (FDA) approval for use:

- Moderna's SPIKEVAX for those 65 and older and for those 6 months to 64 years with at least one <u>high-risk condition</u>.
- Moderna's MNEXSPIKE for those 65 and older and for those 12-64 years with at least one high-risk condition.
- Pfizer's COMIRNATY COVID-19 vaccine was approved for those 65 and older and for those 5-64 years with at least one <u>high-risk condition</u>.
- Novavax's NUVAXOVID for those 65 and older and for those 12-64 years with at least one high-risk condition.
