This communication is being sent to all key contacts at provider organizations enrolled in the pediatric CT Vaccine Program (CVP) – please read this message in its entirety. 2026 CVP Re-Enrollment

This communication is to notify you that the 2026 Connecticut Vaccine Program (CVP) re-enrollment is now open. Each provider site is required to submit a provider agreement annually to re-enroll. The re-enrollment process allows us to verify and update provider shipping information as well as to estimate the amount of vaccine that will need to be supplied for the upcoming calendar year.

Please complete your re-enrollment electronically in Connecticut's Immunization Information System (CT WiZ). Paper forms will not be accepted.

- The Primary and Backup CVP Coordinator and the Medical Director (or equivalent) signing the agreement will each need to have an individual CT WiZ username and password. For information on requesting usernames or help logging into CT WiZ, visit our [username webpage](#).
- For assistance with completing the re-enrollment page, visit our [re-enrollment webpage](#) for step-by-step instructions. The Department of Public Health (DPH) recommends clinics review the [Re-Enrollment Checklist](#) and complete the prerequisite steps before getting started.

- Reminder: As required by [state law](#), all vaccinating providers in Connecticut must provide to patients or post in their office the [notice to patients regarding reporting to CT WiZ](#).

Providers must complete re-enrollment in CT WiZ **by November 21, 2025**.

- Meeting this due date will allow you to continue receiving state supplied vaccine without any interruptions. Failure to complete the profile and agreement forms by November 21, 2025 will result in a delay of future vaccine orders.

Holiday Shipping Schedule

Please find the attached holiday shipping schedule for state supplied vaccines. If you are expecting vaccine orders before the holidays, please plan ahead. Routine shipments from McKesson may take up to 4 business days to process before they are shipped. Providers with limited delivery hours (e.g., clinics not open Monday through Friday, 8 AM–5 PM) may experience additional delays in processing and delivery.

Providers are strongly encouraged to order early during the winter holidays. Providers are also encouraged to maintain a minimum of 4 weeks of inventory to prevent vaccine shortages if orders are delayed due to weather and/or carrier interruptions.

As always, thank you for your ongoing efforts and support of vaccination.
