Whether independently or in partnership, our primary goal is to help clients—either recovering from short or long-term illness, physical assault injuries, accidents, or seeking to improve, stabilize and maintain general wellness--manage their healthcare requirements more efficiently, effectively, and safely at home.

In 2015 Hartford Communities That Care (HCTC) partnered with (HHHS) and Trinity-Saint Francis to provide in-home and out-patient treatment of gun-shot victims and other victims of violent crimes after they are released from Trinity-Saint Francis. HCTC referred 15 of the 25 non-fatal gunshot victims to HHHS for in-home care, and HHHS cared for an additional 32 seriously injured victims that were referred directly from the hospital to HHHS. HCTC concluded that services provided by HHHS resulted in better care and fewer costly rehospitalizations.

Victims of violence frequently face discrimination because of zip code, race, primary language spoken, gender identity, sexual orientation, and physical appearance when seeking care.

HHHS continue to provide high quality care to insured and uninsured victims of crime, often times without a viable payer source.
