A J-1 Visa lottery applicant has the option to view the lottery in person or over the internet.

If the applicant wishes to view the lottery in person, please **RSVP by Thursday, November 10, 2022**, by 5:00 PM EST by sending your full name to dph-pco@ct.gov. Please use "**RSVP In Person**" in the subject line. The entrance to 410 is through the back of the building; applicants must use the call box on the column to the left of the door to reach security. If an applicant's name is received by the deadline, their name will be forwarded to security and upon arrival, the applicant must provide their name and inform security they are here for the "J-1 Visa Lottery." Since visitors must be escorted through the building, we ask that applicants arrive no later than 9:50am to allow the lottery to proceed on time.

Lottery Procedure

On the day of the lottery, pieces of paper inscribed with de-identified IDs unique to each applicant will be placed in a transparent container. These pieces of paper will be uniform in size and shape and indistinguishable from each other and contain no externally visible identifying characteristics or marks.

A DPH staff person will reach into the container and extract a single piece of paper, read, and show the ID to the public, and hand the selected piece of paper to another DPH staff person who will record the ID with a number signifying the order in which the corresponding applicant was drawn. This process will be repeated until all applicants are assigned an order with those selected first having priority to those selected after.

The 7-digit alphanumeric ID will be created by concatenating the last two (2) letters of the applicant's Last Name, the last two (2) letters of the applicant's First Name, and the last three (3) digits of the applicant's Department of State Case Number (DOS#) as the following example demonstrates:
