#### I. GENERAL INFORMATION

#### ■ A. INTRODUCTION

- **1. RFP Name and Number.** DPH RFP # 2025-0906: Best Practice Tobacco Control Programs.
- 2. RFP Summary. The Connecticut Department of Public Health (hereafter "Agency") is seeking proposals to implement and maintain evidence-based tobacco control programs that follow the Centers for Disease Control and Prevention (CDC) Best Practices for Comprehensive Tobacco Control Programs. This RFP contains three areas of practice, Component 1. State and Community Interventions, Component 3. Cessation Interventions, and Component 4. Surveillance and Evaluation. More information on these components is included below.
- **3. RFP Purpose.** The Agency is seeking applicants to implement and maintain Tobacco Control Programs that will reduce the rate of commercial tobacco use in Connecticut through a variety of activities. This RFP aims to reduce the use of commercial tobacco including both combustible products such as traditional cigarettes and cigars as well as non-combustible products such as electronic nicotine delivery systems and synthetic nicotine products.
- **4. Commodity Codes.** The services that the Agency wishes to procure through this RFP are as follows:
  - 0097: Miscellaneous Hospital Supplies (Nicotine Replacement Therapies)
  - 0098: Health Care Services, Health Care Management and Consulting Services
  - 0600: Services (Professional, Support, Consulting, and Miscellaneous Services)
  - 0900: Analytical Services (Non-Medical)

The Agency anticipates additional allocation of funds from fiscal year 2024 which may result in additional awards or funding for selected proposals.

- **6. Eligibility.** Private provider organizations (defined as non-state entities that are either nonprofit or proprietary corporations or partnerships), local health departments and districts, State agencies, and municipalities are eligible to submit proposals in response to this RFP. Individuals with a conflict of interest or who are not a duly formed business entity are ineligible to participate in this procurement.
- **7. Minimum Qualifications of Proposers.** To qualify for a contract award, a proposer must have the following minimum qualifications:
  - Proposers must be a public, nonprofit, or private organization.
  - Proposers must be in good standing with the Agency and have no outstanding, unresolved issues on current or prior contracts with the Agency.
  - Proposers must have knowledge of the community and area to be served including strong collaborations within their proposed community.
  - Proposers must have demonstrated experience and the ability to execute their proposed work plan.
  - Proposers must have accounting and financial reporting systems in place.
  - Proposers must have sound fiscal stability, with sufficient qualified, experienced staff, or the ability to hire qualified personnel, which may include subcontracting with other suppliers to provide the proposed services.
  - Proposers must complete and comply with all requirements as specified in the RFP; proposals that do not follow instructions or include required elements will be deemed incomplete and removed from further review.
- **8. Letter of Intent.** A Letter of Intent (LOI) is required by this RFP. The LOI is non-binding and does not obligate the sender to submit a proposal. The LOI must be submitted to the Official Contact by email by the deadline established in the Procurement Schedule. The LOI must clearly identify the sender, including name, postal address, telephone number, and email address. It is the sender's responsibility to confirm the Agency's receipt of the LOI. Failure to submit the required LOI in accordance with the requirements set forth herein shall result in disqualification from further consideration.

The LOI requirements are as follows:

- No more than one page;
- Clearly identify the entity that will be submitting the proposal;
- Include the selected Component(s) 1, 3, and 4 described in Section 5 above and a brief description of the project; and
- List anticipated partners that will be included in the project.

This project information to be included in the LOI will assist the Department in preparation for review but it is non-binding on the proposers. The proposer who submits an LOI may change the selected components in the final proposal.

**9. Inquiry Procedures.** All questions regarding this RFP or the Agency's procurement process must be directed, in writing, electronically (email) to the Official Contact before the deadline specified in the Procurement Schedule. Early submission of questions is encouraged. Questions will not be accepted or answered verbally, be they in person or over the telephone. All questions received before the deadline(s) will be answered. However, the Agency will not answer questions when the source is unknown (i.e., nuisance or anonymous questions).

Questions deemed unrelated to the RFP, or the procurement process, will not be answered. At its discretion, the Agency may or may not respond to questions received after the deadline. As this RFP requires a Letter of Intent, the Agency reserves the right to answer questions only from those who have submitted such a letter. The Agency may combine similar questions and give only one answer. All questions and answers will be compiled into a written amendment to this RFP. If any answer to any question constitutes a material change to the RFP, the question and answer will be placed at the beginning of the amendment and duly noted as such.

The Agency will release the answers to questions on the date(s) established in the Procurement Schedule. The Agency will publish any and all amendments to this RFP on the State Contracting Portal and on the Agency's RFP webpage. At its discretion, the Agency may distribute any amendments to this RFP to prospective proposers who submitted a Letter of Intent.

- 10. RFP Conference. An RFP conference will not be held.
- **11. Proposal Due Date and Time.** The Official Contact is the **only authorized recipient** of proposals submitted in response to this RFP. Proposals must be <u>received</u> by the Official Contact on or before the following due date and time:

Proposals received after the due date and time will be ineligible and will not be evaluated. The Agency will send an official letter alerting late respondents of ineligibility.

# An acceptable submission must include the following:

- One (1) conforming, electronic copy of the original proposal.
- The proposal must be complete, properly formatted and outlined, and ready for evaluation by the Screening Committee. The proposal must be clearly labeled with the RFP Component under which it is submitted.

Proposers are not required to submit separate attachments and other forms for each proposal.

#### II. PURPOSE OF RFP AND SCOPE OF SERVICES

# ■ A. AGENCY OVERVIEW

The Agency is the state's leader in public health policy and oversight. The Agency is the center of a comprehensive network of public health services and is a partner to local health departments for which it provides advocacy, training and certification, technical assistance and consultation, and specialty services, such as risk assessment, that are not available at the local level. The Agency provides accurate, up-to-date health information to the Governor, the Legislature, the federal government, and local communities. This information is used to monitor the health status of Connecticut's residents, set health priorities, and evaluate the effectiveness of health initiatives. The agency is a regulator focused on health outcomes, maintaining a balance between assuring quality and administrative burden on the personnel, facilities, and programs regulated.

The Agency is currently staffed by over 650 employees organized into twelve branches and offices, each tasked with ensuring and/or providing services to help the agency achieve its mission.

The Agency emphasizes evidence-based practices based on the collection of health data to shape our policy and program initiatives. The Agency works together with its partners and others to provide an integrated public health system that maximizes the public's investment in public health. This RFP is being issued by the Tobacco Control Program (TCP) of the Community, Family Health, and Prevention Branch, Chronic Disease and Injury Prevention Section.

The TCP has the following goals:

- To prevent the initiation of tobacco use.
- To promote quitting of commercial tobacco products among youth and adults.
- To eliminate nonsmokers' exposure to secondhand smoke and aerosol.
- To identify and eliminate the disparities related to tobacco use and reduce its effects on diverse population groups.

#### ■ B. PROGRAM OVERVIEW

The TCP is working to enhance the wellbeing of Connecticut residents by promoting tobaccofree lifestyles and by educating communities about the economic and health costs and consequences of tobacco use. Tobacco use is the single most avoidable cause of death in our society and one of the most important public health issues of our time. Each year in Connecticut, nearly 5,000 adults die from health consequences caused by their own smoking, with hundreds of nonsmokers dying due to exposure to secondhand smoke.<sup>1</sup> In addition to premature deaths, tobacco use causes illness, disability, productivity loss, and is also responsible for high economic costs in healthcare spending. Annual smoking-related expenditures are estimated at over \$2.0 billion in Connecticut, with approximately \$559.8 million of that in costs to the Medicaid Program. Average annual productivity losses are an additional \$3.5 billion.<sup>1</sup> Tobacco use is more prevalent in certain age and demographic groups, and funded programs should target and tailor services to such groups.

In Connecticut in 2022, 18.8% of adults reported using some form of tobacco some days or every day. Men (24.3%) are significantly more likely than women (13.6%) to use tobacco.<sup>2</sup> 12.7% of Connecticut high school youth reported using some form of tobacco in the last 30 days.<sup>3</sup> Among the different age groups, cigarettes are the most prevalent type of tobacco used by adults, and e-cigarettes and other electronic vapor products are the most prevalent type of tobacco product used by high school youth.

Adults aged 18-34 years have the highest rate of tobacco use (27.0%), and those with a college degree (3.6%) were significantly less likely than their counterparts with no high school diploma (18.4%) to have smoked cigarettes some days or every day. Adults who reported having some type of cognitive disability, such as serious difficulties concentrating, remembering, or making decisions (18.4%), were more than twice as likely as their counterparts without these health difficulties (8.9%) to have smoked cigarettes some days or every day.<sup>2</sup>

About 28.5% of adults reported exposure to the smoke, aerosol, or vapor from someone who was smoking or vaping a tobacco or cannabis product in the last seven days (i.e., recent secondhand smoke (SHS) or aerosol exposure). Men (33.3%) are significantly more likely than women (24.1%) to have been recently exposed to SHS or aerosol. Rates of recent exposure are significantly higher for adults between the ages of 18 and 34 (46.7%), those whose highest level of educational attainment was less than a college degree (32.3%), adults who identify as LGBTQ+ (48.5%), and those reporting poor mental health (47.1%).

In 2023, 35.0% of Connecticut high school youth reported recent secondhand tobacco and cannabis smoke or aerosol exposure. The rate of recent exposure among youth is significantly higher for females (38.9%), those with poor mental health (49.6%), and for students who identify as LGBTQ+ (49.3%).

This data is quantified on the tables below, which highlights tobacco use disparities among the different groups who should be targeted for program activities.

Once smoking is initiated, the addictive nature of tobacco makes it very difficult to quit. Estimates are that nearly two-thirds of smokers want to quit, but each year, fewer than 3% of those who want to quit are successful. Although the Connecticut tobacco use rate is lower than the national average, there is still a need for cessation services, especially among select groups within the state population.

Successful tobacco cessation programming is the quickest and most cost-effective means of reducing the public health impact of tobacco use. Brief advice by healthcare providers to quit

smoking can increase cessation rates by 30%. More intensive interventions (including individual, group, or telephone counseling services) that provide social support and training in problem-solving skills are even more effective, increasing cessation rates by 40-100%. FDA-approved medications (e.g., nicotine patch, gum, varenicline, and bupropion SR) are effective, especially when out-of-pocket costs are minimized and combined with counseling and other interventions. Availability of no or low-cost cessation services increases an individual's motivation and readiness to quit.<sup>4</sup>

This RFP for evidence-based programming seeks to identify organizations that have the capacity to develop and implement programs that will reduce and/or eliminate tobacco use - both combustible and non-combustible products - among Connecticut residents. We are striving to create a culture where tobacco-free is the norm.

#### ■ C. BRIEF OVERVIEW OF BEST PRACTICES

The U.S. Department of Health and Human Services, Centers for Disease Control and Prevention (CDC) has developed an evidence-based guide to help states implement comprehensive tobacco control programs that will reduce rates of tobacco use. This coordinated effort to establish smoke- and vape-free policies and social norms, to promote and assist tobacco users to quit, and to prevent initiation of tobacco use combines educational, clinical, regulatory, economic, and social strategies. The guide, "Best Practices for Comprehensive Tobacco Control Programs — 2014" is divided into five areas of practice: 1) State and Community Interventions, 2) Mass-Reach Health Communication Interventions, 3) Cessation Interventions, 4) Surveillance and Evaluation, and 5) Infrastructure Administration and Management.<sup>5</sup> This RFP contains three components which correspond to practice areas 1,3, and 4 detailed below.

1. State and Community Interventions. These interventions target social norms to influence behavior change, using coordinated and combined societal and community resources. Interventions can focus on building community capacity, awareness, engagement, and mobilization; coordination of state efforts, policies, laws, and regulations; and influencing people in their daily environment. These interventions cover a wide range of areas, and a multi-faceted range of interventions is desirable for this solicitation.

All community programs are charged with bringing about environmental change in multiple settings, including worksites, schools, licensed tobacco retailers, multiunit housing, and public spaces such as parks and beaches. These community actions complement and reinforce similar statewide action through three types of activities: use of paid and earned media to raise awareness and educate the community and key community members about the tobacco epidemic; education of government policy makers about the tobacco epidemic to build support for tobacco control policies; and education of organizational decision makers, including tobacco retailers, healthcare organizations, school boards, and community organizations, for policy changes and resolutions.

- **3. Cessation Interventions.** These interventions provide treatment services, such as directly delivering cessation counseling and medications through population-based services such as a telephone quitline, as well as population-level strategic efforts to reconfigure policies and systems to normalize quitting, support tobacco-free lifestyles, and ensure ongoing tobacco use screening and intervention are part of routine medical care.
- **4. Surveillance and Evaluation.** These interventions include surveillance and evaluation. For the purposes of this RFP, surveillance is continually monitoring attitudes and behaviors and health outcomes over time, and evaluation is monitoring and documenting short-term, intermediate, and long-term outcomes within populations. This is accomplished through systematic collection of information about the activities and results of programs to inform decisions about future programming and/or increase understanding. Evaluation also serves to document or measure the effectiveness of programs, including policy and media efforts.

Currently, overall tobacco use surveillance is collected through the Agency's participation in the statewide Behavioral Risk Factor Surveillance System for Connecticut adults and the Connecticut Youth Risk Behavior Survey for high school students.

# **■** E. SCOPE OF SERVICE DESCRIPTION

1. **Organizational Expectations.** The Agency will accept applications from both public and private organizations. The proposal must describe the organization, including its purpose, services provided, and length of time in operation. The proposal must also describe the organization's experience with providing services that would fall within the scope of this RFP, specifically the selected component(s).

The proposal must describe the current range of services provided by the applicant organization and the populations served, including the annual number of individuals reached.

The proposal must also define the location of the applicant organization and their hours of operation, including an accompanying description of how residents can reach their organization.

The following must be provided as attachments to the proposal:

- Three letters of collaboration and support are required from community organizations and project partners that detail their level of involvement to the proposed project.
- A letter of reference is required from one previous funder or grantor that includes a description of the project performed, timeliness of project activities, and completeness of project deliverables.
- 2. Service Expectations. Successful applicants must be able to provide the services included in their proposal. The approach to providing services must be clearly and completely addressed within the proposal. For example, if an applicant proposes targeting youth for interventions, describe how the project will ensure it primarily reaches the 11.2% of youth that currently use tobacco products as opposed to the 88.8% that do not.

If applying for multiple components, a separate Scope of Services and budget forms must be submitted for each component, even if a proposer is proposing one project or initiative that has portions in more than one RFP component. Applicants must specify under which of the following four components they are applying for funding with an overall summary that explains how the interventions will work together.

# a) **COMPONENT 1: STATE AND COMMUNITY INTERVENTIONS**

The State and Community Interventions Component of this RFP focuses on local community-level interventions. These local activities will help to inform statewide initiatives, so coordination of multiple community-level interventions is preferred. Of note, regional or statewide coordination and impact will be weighted more in proposal scoring.

Successful applicants will be responsible for establishing community interventions that address the four TCP goals listed in Section II. A. Applicants may address any one or all the areas listed. A "community" includes a variety of entities that work across different sectors, such as health agencies; civic, social, and recreational

associations; city and town governments; schools and universities; faith organizations; and organizations that support various population groups.

Community engagement and mobilization are an important part of tobacco control programs, and applicants are encouraged to mobilize community partners to engage in a variety of activities that will work together to promote tobacco-free living as a societal norm. A multiple strategy intervention will have a greater effect on the community.

Comprehensive approaches to change community environments and social norms about tobacco use are the most effective way to reduce youth tobacco and nicotine use and prevent youth initiation. Strategies should focus on population-wide approaches and target the general public and decision makers.

Effective, evidence-based efforts are recommended by the CDC, and the Task Force on Community Preventive Services, which typically focus on the following:

- Raising awareness about the importance of and adopting tobacco-free environments.
- Educating about the impact of tobacco product prices.
- Reducing youth access to tobacco products in the retail environment.
- Communicating the dangers of youth tobacco use and secondhand smoke and aerosol exposure.
- Encouraging cessation using evidence-based services.
- Building community awareness of tobacco control efforts, and
- Monitoring and enforcing tobacco control policies.
- 1) Examples of evidence-based interventions include:
  - i. <u>Secondhand Smoke: Interventions that promote the advancement of</u> policies that address secondhand smoke, such as:
    - Smoke-free multiunit housing.
    - Smoke and tobacco-free campuses (i.e. colleges or universities, schools, healthcare facilities, worksites).
    - Local community smoke-free protections (i.e. municipal parks, festivals and events, restaurant patios).
    - Technical assistance including training, education, and support for policy adoption, implementation, and enforcement of smoke and tobacco-free policies.

# ii. Youth Initiation

- Mobilizing community and engaging youth in evidence-based initiatives that prevent tobacco use among youth (tobacco pricing strategies, smoke and tobacco-free protections, and retail environment strategies).
- Tobacco prevention education and intervention in schools in combination with school policy updates.
- Placing statewide media locally and promoting evidence-based quit services that increase youth access to cessation including CT Quitline and Truth Initiative's This is Quitting text program.

 Technical assistance including training and support related to youth leadership and engagement, school education and intervention, peer support, and evidence-based point-of-sale policy.

# iii. Health Equity and Innovation

- Activities that support and engage the LGTBQ+ community, disproportionately impacted racial/ethnic groups, individuals with a mental health condition or disability, people experiencing poverty, and young adults aged 18-35. Activities should be tailored, sensitive, and specific to address disparities in these population groups and interventions should align with tobacco prevention best practices.
- Regional or statewide activities that implement best or promising practices that address tobacco product waste removal and disposal and engage all state and local partners.
- Activities that increase education and awareness in the entertainment industry on impact of tobacco use in movies and television.
- 2) Best practice activities as recommended by CDC include:
  - Developing partnerships and coalitions.
  - ii. Establishing a strategic plan for a comprehensive tobacco control scope of work and collaborating with all stakeholder groups and local and state agencies.
  - iii. Education on evidence-based policy change.
  - iv. Engaging stakeholders and partners in addressing tobacco-related disparities.
  - v. Collecting, disseminating, and analyzing data.
  - vi. Developing and implementing training and technical assistance.
- 3) Discouraged activities include:
  - i. Not following CDC best practice or evidence-based recommendations.
  - ii. Standalone projects that are not part of a comprehensive approach to tobacco prevention (for example: contests, performances, toolkits, prevention school-based programs, etc.).
  - iii. Purchase of smoking or vaping monitoring devices.

Please note, the current Clean Indoor Air Act in Connecticut (Connecticut General Statute Sections 19a-342 and 19a-342a) restricts local municipalities from adopting laws or ordinances pertaining to indoor air through the preemption language in section (g). Voluntary policies may be adopted by any landowner/landlord/manager. In addition, Section 7-148 advises municipalities in section (xvi) to "regulate, on any property owned by the municipality, any activity deemed to be deleterious to public health, including the lighting or carrying of a lighted cigarette, cigar, pipe, or similar device".

# b) **COMPONENT 3: CESSATION INTERVENTIONS**

Successful applicants will be responsible for developing and implementing evidence-based strategies and activities that have been recommended by the CDC's Office on Smoking and Health to reduce, eliminate, and/or prevent tobacco use and secondhand smoke and aerosol exposure by Connecticut residents. Tobacco use reduction is identified as a priority to improve health and decrease healthcare costs.

The Agency has provided quitline services to Connecticut residents for over 20 years. This effort is funded through a separate RFP process.

The CT Quitline provides services 24/7 to all Connecticut residents who want assistance with quitting tobacco, free of charge. These services include telephone, online, and texting support, as well as FDA approved nicotine replacement therapy (NRT) and medications, to those over the age of 18 years old and medically eligible. Alternate language services are also available for participants.

Under the scope of this RFP, the overall cessation intervention goals for Component 3 include promoting health systems change, expanding insurance coverage including the knowledge of available coverage and services, and using proven tobacco use cessation treatments; as well as supporting the CT Quitline. Additional methods to support those who are looking for assistance with tobacco use cessation are desired. Of note, regional or statewide coordination and impact will be weighted more in proposal scoring. Proposals shall include information regarding availability of services in languages other than English.

Examples of evidence-based Cessation Interventions include:

#### i.) Health Systems Change

Successful applicants should conduct outreach and provide education for healthcare providers and systems within their defined service area on the U.S. Department of Health and Human Services – Clinical Practice Guideline: Treating Tobacco Use and Dependence. Outreach and education will include content on the importance of screening all patients for tobacco use, advising them to quit, and referring them to cessation services.

Successful applicants should also work with employers and worksites in their service area to educate them on the benefits of providing coverage for, and offering, tobacco use cessation services to their employees – services that should be included as an insurance benefit as defined by the Affordable Care Act. This is to promote coverage of and access to tobacco use cessation services.

Example activities include:

# 1.) Education and Training

- Promoting and providing comprehensive educational training programs for individuals to provide tobacco treatment services with healthcare or community settings.
- Training health care providers on how to screen for tobacco use and conduct culturally appropriate and tailored brief intervention counseling and treatment.
- Educating health care providers on the billing option for Medicaid and other insurance plans for tobacco use treatment services.
- Educating employers on the health and economic benefits, including lost productivity, of providing tobacco use cessation insurance coverage for employees.
- Educating employers on referrals to established cessation programs including the CT Quitline as a method of providing additional cessation support.

#### 2.) Technical Assistance and Promotion

- Promoting referrals to the CT Quitline and integrating electronic referrals into workflows and electronic health records.
- Encouraging and assisting employers in developing campus-wide tobaccofree worksite policies.

## ii.) Supporting State Quitline Capacity

Successful applicants will be expected to provide culturally appropriate, tailored direct cessation services that support and engage groups that experience tobacco product disparities. Priority populations include: LGTBQ+ communities, racial and ethnic minorities, veterans, individuals with mental health conditions or disabilities, people experiencing poverty, and high school students, and young adults aged 18-35. Funding may be used to cover the portion of tobacco use cessation services that are not covered by insurance.

# iii.) Direct Cessation Service Activities

# 1.) Outreach

- Refer tobacco users to the CT Quitline and Vape Free CT.
- Promote tobacco use cessation programs onsite at community sites such as, but not limited to workplaces, community locations, and multi-unit housing sites.

#### 2.) Counseling

- Offer and provide individual and group tobacco use cessation counseling programs and relapse prevention counseling by a program administrator qualified as a trained cessation coach.
- Availability of alternate language services is encouraged.
- Provide incentives to improve ongoing enrollments, attendance, and follow-up rates in cessation programs.

- 3.) Nicotine Replacement Therapies or Medications
  - When medically appropriate, provide FDA approved NRT and medications.
  - Participants must be enrolled in counseling to receive NRT or medications.

Please note, medications are not FDA-approved for those under 18 years of age; coordination with their health care provider is necessary if medications are indicated for cessation.

Preference will be given to activities that are based on best practices and evidence- based approaches as described in Section II.C. & D.

A full outline of what the tobacco use cessation program curriculum must include, if direct cessation services are being provided, is listed in the informational appendices in Section VI.D.

# **Required Activities:**

All COMPONENT 3 respondents also see SECTION: "d) ALL COMPONENTS" for additional services to be provided

# c) **COMPONENT 4: SURVEILLANCE AND EVALUATION**

The successful applicant must develop and implement an overall formative process and outcome evaluation plan that will provide valid, reliable evidence of progress achieved through the tobacco use prevention and cessation efforts by all applicants awarded funding.

The successful applicant shall work with the Agency to provide independent thirdparty evaluation services for the TCP. The successful applicant will evaluate program, service, and project progress, determine effectiveness, determine if desired results are being obtained, and identify any areas that need improvement. The successful applicant will make comparisons among population groups to determine the effectiveness of targeted programs.

Applicants for all components are required to submit draft evaluation plans and logic models with their applications that include the anticipated outcome measures for each of their initiatives, as described in Subsection II.E.2.e. below.

The successful applicant will review the submitted plans and provide feedback, recommendations, and support to each contractor to ensure programs are established that have measurable objectives.

The successful applicant will assist with analyzing collected data to report program effectiveness, provide overall summary results of all programs for reporting purposes, and conduct the final data analysis of the projects funded under all Components of this RFP. The evaluation goals include determining the effectiveness of the TCP in promoting tobacco-free policies, reducing tobacco use, and achieving tobacco use cessation and the efficacy of integrating cessation services into agency operations.

Areas to be evaluated may include overall system changes, tobacco use reduction, quit rates, cost per quit, and overall administration and program effectiveness, dependent on the programs proposed.

The successful applicant will examine progress towards reducing tobacco use in the client population and the ability to reach targeted populations. The successful applicant will identify strengths and weaknesses for use in future planning and implementation and identify areas in need of additional services and/or programmatic changes.

# **Required Activities:**

All COMPONENT 4 respondents continue to the next section: "d) ALL COMPONENTS" for additional services to be provided"

# d) ALL COMPONENTS

All applicants must include the following information regarding additional services to be provided as part of the scope of services:

- 1.) State the target population for each intervention that is described in your proposal and describe each intervention in as much detail as possible. This should include the length of time, number of sessions if applicable, curriculum to be developed and/or used if applicable, materials that will be provided or developed through this effort, and any pertinent details that will further describe your proposed project.
- 2.) The applicant should explain their capability for collaborating with other contractors as necessary for this initiative. For instance, applicants awarded contracts under Component 1 will have to collaborate with the evaluation contractor awarded under Component 4.
- 3.) Describe your process for meeting reporting deadlines and providing narrative updates. Contractors will need to submit written narrative reports that demonstrate program progress, including, but not limited to, number and dates of meetings/sessions/programs held, number of people reached, and other data elements based on the type of program being offered.
- 4.) If you have previously provided any of the services included in this RFP (e.g., tobacco use cessation services, tobacco prevention programming, or healthcare systems outreach), provide a summary of program successes and results, "lessons learned", and how you overcame any challenges.
- 5.) If you are currently funded for similar activities, describe how the activities proposed in your new application will expand on (not duplicate) similar initiatives. For example, describe the additional service area and/or additional populations that will be targeted, added capacity building activities, etc.
- 6.) Contractors will need to submit a final report that includes their self-assessment of the project: program summary and status, marketing of their program including outreach activities, accomplishments, the effectiveness of services provided, determination of project successes, descriptions of challenges encountered, what did and did not work, and what suggestions could be made

for changes for the future. In the application, describe your process for the self-assessment of this project.

- 7.) Describe how your program will be sustainable once these contract funds have expired.
- **3. Evaluation Plan.** Applicants for all components should explain their capability to work with a third-party evaluator to collect and provide program data and determine overall program effectiveness. Contractors are expected to cooperate and collaborate with this evaluation vendor hired for the independent evaluation of these tobacco control programs.

Evaluation shall be ongoing with these initiatives. Each applicant needs to provide a draft evaluation plan for each component with their proposal that includes effective use of available data. A logic model template is included in the appendices to assist applicants with this process; a logic model is required for each component and needs to be part of the evaluation plan.

The evaluation plan format should include the following:

- Measurable Objective(s)
- Method for Collecting Measure(s)
- Data Source(s)
- Frequency
- Responsibility

The Logic Model should include the following:

- Method for Collecting Measure(s)
- Inputs
- Activities
- Outputs
- Outcomes (Short Term, Interim, Long Term)

The selected evaluator will review the draft evaluation plans to make recommendations for better program documentation to measure program effectiveness.

**4. Work Plan.** A comprehensive and realistic work plan must be provided on the Work Plan Form included in Section VI. The work plan must be consistent with the RFP and provide details on the proposed project, including project goals, interventions, or services to be provided, the responsible staff position and target population for each activity, timeframe for completion, including a project start date, and the expected outcome or measure of success for that activity. Details should be provided about the relationship and tasks to be performed by each subcontractor, if applicable.

The work plan form shall be completed in the required format provided in the appendices and included as an attachment. It does not count toward the page limit. (See Section VI.).

**5. Staffing Expectations.** Staff assigned to this project need to have the appropriate training and experience to perform the proposed services. The proposal must describe the staff assigned to this project, including the extent to which they have the

appropriate training, experience, and sufficient time allocated to perform the assigned duties.

Resumes for management and professional staff must be included with the proposal; one point of contact will be requested for the successful applicant.

Staff should be familiar with evidence-based programming and an ability to address the needs of the target population.

A current organizational chart for the applicant organization, with details specific to the proposed project, must be submitted with the attachments.

Please consider, the proposal must include a completed Subcontractor Schedule A—Detail Form for each subcontractor proposed (If known at application time, otherwise, will be required to submit during contract negotiations, see Section V1. - Appendices)

6. Data and Technology Expectations. The applicant must develop and maintain a data collection system that can collect, store, and report any data elements to the Agency that are needed to report on program outcomes, such as participant information, status of coverage for cessation services, policy adoption status, or partner communication lists.

The applicant should describe their quality assurance process (e.g., conduct periodic data assessments to evaluate the quality, accuracy, and validity of the data; assess, and validate data collection methods used by staff). Discussion of data management must include plans for quality improvement such as modifications to operations, protocols, data elements, software and/or equipment, staff training, and improved communication methods.

The applicant must include development and/or maintenance of a data recovery plan that ensures that files and programs can be restored in the event of loss by any cause including their plan to safeguard data files.

The Agency will require monthly and/or quarterly reports from each contractor to report program data on an ongoing basis. The frequency of these reports will depend on the type of program and services to be offered. Reporting is a critical component to be able to document ongoing need and use of the services provided.

The selected contractor(s) under Component 1 and 3 will also be expected to respond to questions from the independent evaluator on data submissions and program operations and may be expected to make data collection modifications, as requested by the Agency, to assure that necessary data to measure outcomes is being tracked.

7. Financial Expectations. Monthly or quarterly expenditure reports will be required, dependent on the type and cost of program to be provided. The applicant must have a process in place used by program and fiscal staff to ensure adequate reporting, reconciliation, and tracking of program expenditures.

The applicant must have financial control procedures in place to verify the actual expenditures that will be charged to this program. This may include a Cost Allocation Plan if administrative and general costs will be charged, or a Time and Effort reporting system, to verify work performed by staff charged to this program.

Budget basis programs will require expenditure reports that are submitted to the Agency through an electronic reporting system, Core-CT.

Any services that are going to be provided on a fee-for-service basis need to include an invoice. Costs for services provided will be reimbursed for the prior month of service. The contractor will be expected to submit monthly invoices as well as the necessary back-up data to support the invoice charges. The Agency will work with the Contractor to develop an acceptable format for the invoice.

The applicant must have a process for reimbursing subcontractors in a timely manner.

The applicant must include the most recent two years of annual audited financial statements, or any financial statements prepared by a Certified Public Accountant, including the auditor's management letter and corrective action plan, if applicable.

**8. Budget Expectations.** Funding for these tobacco control programs has been allocated by the Tobacco and Health Trust Fund to the Agency. The amount of contract funds awarded to each successful applicant will vary based upon the nature and scope of the work to be performed. Applicants applying for funds under multiple components must supply separate budgets for each Component 1, 3, or 4.

Proposals must contain an itemized budget with justification for each line item included in the budget forms included in the Application Forms provided in Section VI.

- a. All costs (salaries, travel, supplies, etc.) to be charged in the contract must be included in the proposed budget. The maximum amount of the bid may not be increased after the proposal is submitted. All cost estimates will be considered as "not to exceed" quotations against which time and expenses will be charged.
- b. The State of Connecticut is exempt from the payment of excise, transportation and sales taxes imposed by the Federal and/or state government. Such taxes must not be included in the contract price.
- c. These funds cannot be used for any capital purchases, including to purchase or improve land; purchase, construct, or permanently improve a building or facility; or purchase major medical equipment.
- d. The use of subcontractors is allowed. Subcontractor information and details must be included in the itemized budget. All information required of the contractor must be applied to the subcontractor as well.
- e. Any organization that includes administrative and general costs as part of the project budget must also provide their cost allocation plan that identifies which costs are included in the plan and how they are allocated.
- f. Competitiveness of the budget will be considered as part of the proposal review process.
- g. The proposed budget amounts requested by successful applicants are subject to change and may be amended during the contract award negotiation process.

#### **■ F. PERFORMANCE MEASURES**

A work plan format example is provided with the application forms. A work plan is required for each component that needs to include specific details about the interventions and/or services to be performed, the proposed activities to be performed as part of the intervention or service, the responsible staff position and target population for each activity, and the expected outcome or measure of success for that activity.

All interventions and/or services should be described in as much detail as possible. This may include information such as what curriculum will be used, the length of time for each program or session, materials that will be provided or developed through this effort, and any pertinent details that will further describe your proposed project.

The expected outcome or measure of success will be further described within the draft evaluation plan, which is to be prepared as a separate document.

The performance metrics below highlight sample key priorities that might be analyzed with providers collaboratively during the life of the contract; the set performance measures depend on the selected Component(s) and the scope of work.

The Agency looks forward to working with providers to define additional important performance metrics.

Though not an exhaustive list, a sample of the types of Performance Measures that have been used with similar programs include the following:

Providers should propose key metrics based upon their program type and activities; key metrics will be included within the required evaluation plan.

# ■ G. CONTRACT MANAGEMENT/DATA REPORTING

As part of the State's commitment to becoming more outcomes-oriented, the TCP seeks to actively and regularly collaborate with providers to enhance contract management, improve results, and adjust service delivery and policy based on learning what works.

Reliable and relevant data is necessary to ensure compliance, inform trends to be monitored, evaluate results and performance, and drive service improvements. As such, the TCP reserves the right to request/collect other key data and metrics from providers, as service needs or national requirements may change from time to time.

#### III. PROPOSAL SUBMISSION OVERVIEW

#### ■ A. SUBMISSION FORMAT INFORMATION

- 1. **Required Outline.** All proposals must follow the required outline presented in Section IV Proposal Outline. Proposals that fail to follow the required outline will be deemed non-responsive and will not be evaluated.
- **2. Cover Sheet.** The Cover Sheet is both Page 1 and Page 2 of the proposal. The RFP Section VII provides the application forms including the Cover Page; proposers must complete and use this Cover Sheet form provided by the Agency.
  - Contact Person is defined as the individual who can provide additional information about the proposal or who has immediate responsibility for the proposal.
  - Authorized Official is defined as the individual empowered to submit a binding
    offer on behalf of the proposer to provide services in accordance with the terms
    and provisions described in this RFP and any amendments or attachments
    hereto.
  - a. **Table of Contents.** All proposals must include a Table of Contents that conforms with the required proposal outline; the Program has provided an Outline for the Table of Contents in the Application Forms Appendix.
  - b. **Executive Summary.** Proposals must include a high-level summary, not exceeding three (3) pages of the main proposal and cost proposal. The summary must also include the organization's eligibility and qualifications to respond to this RFP.
  - c. **Main Proposal/Scope of Services.** Proposals must a include a scope of services detailing how they will deliver services under the selected component(s). The activities within scope of service must align with the requirements outlined throughout the RFP.
  - d. **Attachments.** Three letters of collaboration and support are required from community organizations and project partners that detail the level of involvement and evidence of assistance that they will provide to the project.

A letter of reference is required from one previous employer/grantor that includes a description of the project performed, timeliness of project activities, and completeness of project deliverables.

Letters of reference and letters of collaboration and support should be currently dated, and not copies from previous submissions. Letters of reference and collaboration and support cannot be provided by DPH staff.

Attachments other than the required Attachments, Forms, and Letters identified may not be evaluated. Further, the required Attachments or Forms must not be altered or used to extend, enhance, or replace any component required by this RFP. Failure to

abide by these instructions may result in disqualification.

# 3. Style Requirements.

An electronic submission shall be emailed to the Official Agency Contact in a .pdf format.

Please note, the pre-designed forms do NOT need to be re-formatted to fit within the above specifications.

- **4. Pagination.** The proposer's name must be displayed in the header of each page. All pages must be numbered in the footer.
- **5. Declaration of Confidential Information.** Proposers are advised that all materials associated with this procurement are subject to the terms of the Freedom of Information Act (FOIA), the Privacy Act, and all rules, regulations and interpretations resulting from them. If a proposer deems that certain information required by this RFP is confidential, the proposer must label such information as CONFIDENTIAL prior to submission. In subsection E of the proposal submission, the proposer must reference where the information labeled CONFIDENTIAL is in the proposal. *EXAMPLE: Section G.1.a.* For each subsection so referenced, the proposer must provide a convincing explanation and rationale sufficient to justify an exemption of the information from release under the FOIA. The explanation and rationale must be stated in terms of (a) the prospective harm to the competitive position of the proposer that would result if the identified information were to be released and (b) the reasons why the information is legally exempt from release pursuant to C.G.S. § 1-210(b).
- 6. Conflict of Interest Disclosure Statement. Proposers must include a disclosure statement concerning any current business relationships (within the last three (3) years) that pose a conflict of interest, as defined by C.G.S. § 1-85. A conflict of interest exists when a relationship exists between the proposer and a public official (including an elected official) or State employee that may interfere with fair competition or may be adverse to the interests of the State. The existence of a conflict of interest is not, in and of itself, evidence of wrongdoing. A conflict of interest may, however, become a legal matter if a proposer tries to influence, or succeeds in influencing, the outcome of an official decision for their personal or corporate benefit. The Agency will determine whether any disclosed conflict of interest poses a substantial advantage to the proposer over the competition, decreases the overall competitiveness of this procurement, or is not in the best interests of the State. In the absence of any conflict of interest, a proposer must affirm such in the disclosure statement. Example: "[name of proposer] has no current business relationship (within the last three (3) years) that poses a conflict of interest, as defined by C.G.S. § 1-85."

#### **■** B. EVALUATION OF PROPOSALS

- 1. **Evaluation Process.** It is the intent of the Agency to conduct a comprehensive, fair, and impartial evaluation of proposals received in response to this RFP. When evaluating proposals, negotiating with successful proposers, and awarding contracts, the Agency will conform with its written procedures for Purchase of Service (POS) and Personal Service Agreement (PSA) procurements (pursuant to C.G.S. § 4-217) and the State's Code of Ethics (pursuant to C.G.S. §§ 1-84 and 1-85). Final funding allocation decisions will be determined during contract negotiation.
- 2. Evaluation Review Committee. The Agency will designate a Review Committee for each Component of this RFP, to evaluate proposals submitted in response to this RFP. Applicants who wish to respond to more than one Component must submit a separate scope of services for each Component to allow the separate review committees to appropriately evaluate each applicant. The Review Committee will be composed of individuals, Agency staff or other designees as deemed appropriate. The contents of all submitted proposals, including any confidential information, will be shared with the Review Committee. Only proposals found to be responsive (that is, complying with all instructions and requirements described herein) will be reviewed, rated, and scored. Proposals that fail to comply with all instructions will be rejected without further consideration. The Review Committee shall evaluate all proposals that meet the Minimum Submission Requirements by score and rank ordered and make recommendations for awards. The Commissioner of Public Health will make the final selection. Attempts by any proposer (or representative of any proposer) to contact or influence any member of the Review Committee may result in disqualification of the proposer.
- **3. Minimum Submission Requirements.** To be eligible for evaluation, proposals must (1) be received on or before the due date and time; (2) meet the Proposal Format requirements; (3) meet the Eligibility and Qualification requirements to respond to the procurement, (4) follow the required Proposal Outline; and (5) be complete. Proposals that fail to follow instructions or satisfy these minimum submission requirements will not be reviewed further. The Agency will reject any proposal that deviates significantly from the requirements of this RFP.
- **4. Evaluation Criteria.** Proposals meeting the Minimum Submission Requirements will be evaluated according to the established criteria. The criteria are the objective standards that the Review Committee will use to evaluate the technical merits of the proposals. Only the criteria listed below will be used to evaluate proposals.

# Staffing Plan including Subcontractors

- o Comprehensive and technically sound approaches
- Allocation of a sufficient number of staff in the appropriate position classification(s) to perform the full range of services
- Availability of alternate language services
- A qualified program administrator responsible for overseeing the overall operation of the program, functioning as the single point of contact
- If providing direct cessation services, a qualified coach/counselor responsible for providing services to program participants
- Identification of staff to oversee any necessary day-to-day data collection including entering any necessary data for reporting on program outcomes for required reports while ensuring data quality and accuracy
- Demonstration of capability to effectively coordinate, manage, and monitor the efforts of assigned staff, including subcontractors, to ensure that work is effectively completed in a timely manner

Note: As part of its evaluation of the Staffing Plan, the Review Committee will review the proposer's demonstrated commitment to affirmative action, as required by the Regulations of CT State Agencies § 46A-68j-30(10).

**5. Proposer Selection.** Upon completing its evaluation of proposals, the Review Committee will submit the rankings of all proposals within each Component to the Commissioner. The final selection of successful proposers is at the discretion of the Commissioner. Any proposer selected will be so notified and awarded an opportunity to negotiate a contract with the Agency. Such negotiations may, but will not automatically, result in a contract. Any resulting contract will be posted on the State Contracting Portal. All unsuccessful proposers will be notified by email or U.S. mail, at the Agency's discretion, about the outcome of the evaluation and proposer selection process. The Agency reserves the right to decline to award contracts for activities in which the Commissioner considers there are not adequate respondents.

- **6. Debriefing.** Within ten (10) days of receiving notification from the Agency, unsuccessful proposers may contact the Official Contact and request information about the evaluation and proposer selection process. The email sent date or the postmark date on the notification envelope will be considered "day one" of the ten (10) days. If unsuccessful proposers still have questions after receiving this information, they may contact the Official Contact and request a meeting with the Agency to discuss the evaluation process and their proposals. If held, the debriefing meeting will not include any comparisons of unsuccessful proposals with other proposals. The Agency may schedule and hold the debriefing meeting within fifteen (15) days of the request. The Agency will not change, alter, or modify the outcome of the evaluation or selection process as a result of any debriefing meeting.
- 7. Appeal Process. Proposers may appeal any aspect of the Agency's competitive procurement, including the evaluation and proposer selection process. Any such appeal must be submitted to the Commissioner. A proposer may file an appeal at any time after the proposal due date, but not later than thirty (30) days after an agency notifies unsuccessful proposers about the outcome of the evaluation and proposer selection process. The email sent date or the postmark date on the notification envelope will be considered "day one" of the thirty (30) days. The filing of an appeal shall not be deemed sufficient reason for the Agency to delay, suspend, cancel, or terminate the procurement process or execution of a contract. More detailed information about filing an appeal may be obtained from the Official Contact.
- **8. Contract Execution.** Any contract developed and executed because of this RFP is subject to the Agency's contracting procedures, which may include approval by the Office of the Attorney General. Fully executed and approved contracts will be posted on the State Contracting Portal and the Agency website.

#### V. MANDATORY PROVISIONS

# ■ A. POS STANDARD CONTRACT, PARTS I AND II

By submitting a proposal in response to this RFP, the proposer implicitly agrees to comply with the provisions of Parts I and II of the State's "standard contract" for POS:

Part I of the standard contract is maintained by the Agency and will include the scope of services, contract performance, quality assurance, reports, terms of payment, budget, and other program-specific provisions of any resulting POS contract. A sample of Part I is available from the Department's Official Contact upon request.

Part II of the standard contract is maintained by OPM and includes the mandatory terms and conditions of the POS contract. Part II is available on OPM's website at: http://www.ct.gov/opm/fin/standard\_contract.

#### Note:

Included in Part II of the standard contract is the State Elections Enforcement Commission's notice (pursuant to C.G.S. § 9-612(f)(2)) advising executive branch State contractors and prospective State contractors of the ban on campaign contributions and solicitations. If a proposer is awarded an opportunity to negotiate a contract with the Agency and the resulting contract has an anticipated value in a calendar year of \$50,000 or more, or a combination or series of such agreements or contracts has an anticipated value of \$100,000 or more, the proposer must inform the proposer's principals of the contents of the SEEC notice.

Part I of the standard contract may be amended by means of a written instrument signed by the Department, the selected proposer (contractor), and, if required, the Attorney General's Office. Part II of the standard contract may be amended only in consultation with, and with the approval of, the Office of Policy and Management and the Attorney General's Office.

# **■** B. ASSURANCES

By submitting a proposal in response to this RFP, a proposer implicitly gives the following assurances:

- 1. **Collusion.** The proposer represents and warrants that the proposer did not participate in any part of the RFP development process and had no knowledge of the specific contents of the RFP prior to its issuance. The proposer further represents and warrants that no agent, representative, or employee of the State participated directly in the preparation of the proposer's proposal. The proposer also represents and warrants that the submitted proposal is in all respects fair and is made without collusion or fraud.
- 2. State Officials and Employees. The proposer certifies that no elected or appointed official or employee of the State has or will benefit financially or materially from any contract resulting from this RFP. The Agency may terminate a resulting contract if it is determined that gratuities of any kind were either offered or received by any of the aforementioned officials or employees from the proposer, contractor, or its agents or employees.

- 3. Competitors. The proposer assures that the submitted proposal is not made in connection with any competing organization or competitor submitting a separate proposal in response to this RFP. No attempt has been made, or will be made, by the proposer to induce any other organization or competitor to submit, or not submit, a proposal for the purpose of restricting competition. The proposer further assures that the proposed costs have been arrived at independently, without consultation, communication, or agreement with any other organization or competitor for the purpose of restricting competition. Nor has the proposer knowingly disclosed the proposed costs on a prior basis, either directly or indirectly, to any other organization or competitor.
- **4. Validity of Proposal.** The proposer certifies that the proposal represents a valid and binding offer to provide services in accordance with the terms and provisions described in this RFP and any amendments or attachments hereto. The proposal shall remain valid for a period of 180 days after the submission due date and may be extended beyond that time by mutual agreement. At its sole discretion, the Agency may include the proposal, by reference or otherwise, into any contract with the successful proposer.
- **5. Press Releases.** The proposer agrees to obtain prior written consent and approval of the Agency for press releases that relate in any manner to this RFP or any resultant contract.

#### ■ C. TERMS AND CONDITIONS

By submitting a proposal in response to this RFP, a proposer implicitly agrees to comply with the following terms and conditions:

- **1. Equal Opportunity and Affirmative Action.** The State is an Equal Opportunity and Affirmative Action employer and does not discriminate in its hiring, employment, or business practices. The State is committed to complying with the Americans with Disabilities Act of 1990 (ADA) and does not discriminate on the basis of disability in admission to, access to, or operation of its programs, services, or activities.
- **2. Preparation Expenses.** Neither the State nor the Agency shall assume any liability for expenses incurred by a proposer in preparing, submitting, or clarifying any proposal submitted in response to this RFP.
- **3. Exclusion of Taxes.** The Agency is exempt from the payment of excise and sales taxes imposed by the federal government and the State. Proposers are liable for any other applicable taxes.
- **4. Proposed Costs.** No cost submissions that are contingent upon a State action will be accepted. All proposed costs must be fixed through the entire term of the contract.
- **5.** Changes to Proposal. No additions or changes to the original proposal will be allowed after submission. While changes are not permitted, the Agency may request and authorize proposers to submit written clarification of their proposals, in a manner or format prescribed by the Agency, and at the proposer's expense.
- **6. Supplemental Information.** Supplemental information will not be considered after the deadline submission of proposals, unless specifically requested by the Agency. The Agency may ask a proposer to give demonstrations, interviews, oral presentations or further explanations to clarify information contained in a proposal. Any such

demonstration, interview, or oral presentation will be at a time selected and in a place provided by the Agency. At its sole discretion, the Agency may limit the number of proposers invited to make such a demonstration, interview, or oral presentation and may limit the number of attendees per proposer.

- **7. Presentation of Supporting Evidence.** If requested by the Agency, a proposer must be prepared to present evidence of experience, ability, data reporting capabilities, financial standing, or other information necessary to satisfactorily meet the requirements set forth or implied in this RFP. The Agency may make onsite visits to an operational facility or facilities of a proposer to evaluate further the proposer's capability to perform the duties required by this RFP. At its discretion, the Agency may also check or contact any reference provided by the proposer.
- **8. RFP Is Not An Offer.** Neither this RFP nor any subsequent discussions shall give rise to any commitment on the part of the State or the Agency or confer any rights on any proposer unless and until a contract is fully executed by the necessary parties. The contract document will represent the entire agreement between the proposer and the Agency and will supersede all prior negotiations, representations or agreements, alleged or made, between the parties. The State shall assume no liability for costs incurred by the proposer or for payment of services under the terms of the contract until the successful proposer is notified that the contract has been accepted and approved by the Agency and, if required, by the Attorney General's Office.

#### ■ D. RIGHTS RESERVED TO THE STATE

By submitting a proposal in response to this RFP, a proposer implicitly accepts that the following rights are reserved to the State:

- **1. Timing Sequence.** The timing and sequence of events associated with this RFP shall ultimately be determined by the Agency.
- **2. Amending or Canceling RFP.** The Agency reserves the right to amend or cancel this RFP on any date and at any time, if the Agency deems it to be necessary, appropriate, or otherwise in the best interests of the State.
- **3. No Acceptable Proposals.** In the event that no acceptable proposals are submitted in response to this RFP, the Agency may reopen the procurement process, if it is determined to be in the best interests of the State.
- 4. Award and Rejection of Proposals. The Agency reserves the right to award in part, to reject any and all proposals in whole or in part, for misrepresentation or if the proposal limits or modifies any of the terms, conditions, or specifications of this RFP. The Agency may waive minor technical defects, irregularities, or omissions, if in its judgment the best interests of the State will be served. The Agency reserves the right to reject the proposal of any proposer who submits a proposal after the submission date and time.
- 5. Sole Property of the State. All proposals submitted in response to this RFP are to be the sole property of the State. Any product, whether acceptable or unacceptable, developed under a contract awarded as a result of this RFP shall be the sole property of the State, unless stated otherwise in this RFP or subsequent contract. The right to

publish, distribute, or disseminate any and all information or reports, or part thereof, shall accrue to the State without recourse.

- 6. Contract Negotiation. The Agency reserves the right to negotiate or contract for all or any portion of the services contained in this RFP. The Agency further reserves the right to contract with one or more proposer(s) for such services. After reviewing the scored criteria, the Agency may seek Best and Final Offers (BFO) on cost from proposers. The Agency may set parameters on any BFOs received.
- 7. Clerical Errors in Award. The Agency reserves the right to correct inaccurate awards resulting from its clerical errors. This may include, in extreme circumstances, revoking the awarding of a contract already made to a proposer and subsequently awarding the contract to another proposer. Such action on the part of the State shall not constitute a breach of contract on the part of the State since the contract with the initial proposer is deemed to be void ab initio and of no effect as if no contract ever existed between the State and the proposer.
- **8. Key Personnel.** When the Agency is the sole funder of a purchased service, the Agency reserves the right to approve any additions, deletions, or changes in key personnel, with the exception of key personnel who have terminated employment. The Agency also reserves the right to approve replacements for key personnel who have terminated employment. The Agency further reserves the right to require the removal and replacement of any of the proposer's key personnel who do not perform adequately, regardless of whether they were previously approved by the Agency.

#### **■ E. STATUTORY AND REGULATORY COMPLIANCE**

By submitting a proposal in response to this RFP, the proposer implicitly agrees to comply with all applicable State and federal laws and regulations, including, but not limited to, the following:

- 1. Freedom of Information, C.G.S. § 1-210(b). The Freedom of Information Act (FOIA) generally requires the disclosure of documents in the possession of the State upon request of any citizen, unless the content of the document falls within certain categories of exemption, as defined by C.G.S. § 1-210(b). Proposers are generally advised not to include in their proposals any confidential information. If the proposer indicates that certain documentation, as required by this RFP, is submitted in confidence, the State will endeavor to keep said information confidential to the extent permitted by law. The State has no obligation to initiate, prosecute, or defend any legal proceeding or to seek a protective order or other similar relief to prevent disclosure of any information pursuant to a FOIA request. The proposer has the burden of establishing the availability of any FOIA exemption in any proceeding where it is an issue. While a proposer may claim an exemption to the State's FOIA, the final administrative authority to release or exempt any or all material so identified rests with the State. In no event shall the State or any of its employees have any liability for disclosure of documents or information in the possession of the State and which the State or its employees believe(s) to be required pursuant to the FOIA or other requirements of law.
- 2. Contract Compliance, C.G.S. § 4a-60 and Regulations of CT State Agencies §§ 46a-68j-21 thru 43, inclusive. CT statute and regulations impose certain obligations on State agencies (as well as contractors and subcontractors doing business with the

State) to ensure that State agencies do not enter into contracts with organizations or businesses that discriminate against protected class persons.

- 3. Consulting § Agreements, C.G.S. 4a-81. Consulting Agreements Representation, C.G.S. § 4a-81. Pursuant to C.G.S. § 4a-81, the successful contracting party shall certify that it has not entered into any consulting agreements in connection with this Contract, except for the agreements listed below. "Consulting agreement" means any written or oral agreement to retain the services, for a fee, of a consultant for the purposes of (A) providing counsel to a contractor, vendor, consultant or other entity seeking to conduct, or conducting, business with the State, (B) contacting, whether in writing or orally, any executive, judicial, or administrative office of the State, including any department, institution, bureau, board, commission, authority, official or employee for the purpose of solicitation, dispute resolution, introduction, requests for information, or (C) any other similar activity related to such contracts. "Consulting agreement" does not include any agreements entered into with a consultant who is registered under the provisions of chapter 10 of the Connecticut General Statutes as of the date such contract is executed in accordance with the provisions of section 4a-81 of the Connecticut General Statutes. Such representation shall be sworn as true to the best knowledge and belief of the person signing the resulting contract and shall be subject to the penalties of false statement.
- 4. Campaign Contribution Restriction, C.G.S. § 9-612. For all State contracts, defined in section 9-612 of the Connecticut General Statutes as having a value in a calendar year of \$50,000 or more, or a combination or series of such agreements or contracts having a value of \$100,000 or more, the authorized signatory to the resulting contract must represent that they have received the State Elections Enforcement Commission's notice advising state contractors of state campaign contribution and solicitation prohibitions, and will inform its principals of the contents of the notice, as set forth in "Notice to Executive Branch State Contractors and Prospective State Contractors of Campaign Contribution and Solicitation Limitations." - 5. Gifts, C.G.S. § 4-252. Pursuant to section 4-252 of the Connecticut General Statutes and Acting Governor Susan Bysiewicz's Executive Order No. 21-2, the Contractor, for itself and on behalf of all of its principals or key personnel who submitted a bid or proposal, represents:
  - (1) That no gifts were made by (A) the Contractor, (B) any principals and key personnel of the Contractor, who participate substantially in preparing bids, proposals or negotiating State contracts, or (C) any agent of the Contractor or principals and key personnel, who participates substantially in preparing bids, proposals or negotiating State contracts, to (i) any public official or State employee of the State agency or quasi- public agency soliciting bids or proposals for State contracts, who participates substantially in the preparation of bid solicitations or requests for proposals for State contracts or the negotiation or award of State contracts, or (ii) any public official or State employee of any other State agency, who has supervisory or appointing authority over such State agency or quasi-public agency;

- (2) That no such principals and key personnel of the Contractor, or agent of the Contractor or of such principals and key personnel, knows of any action by the Contractor to circumvent such prohibition on gifts by providing for any other principals and key personnel, official, employee or agent of the Contractor to provide a gift to any such public official or State employee; and
- (3) That the Contractor is submitting bids or proposals without fraud or collusion with any person.

Any bidder or proposer that does not agree to the representations required under this section shall be rejected and the State agency or quasi-public agency shall award the contract to the next highest ranked proposer or the next lowest responsible qualified bidder or seek new bids or proposals.

- 6. Iran Energy Investment Certification C.G.S. § 4-252a. Pursuant to C.G.S. § 4-252a, the successful contracting party shall certify the following: (a) that it has not made a direct investment of twenty million dollars or more in the energy sector of Iran on or after October 1, 2013, as described in Section 202 of the Comprehensive Iran Sanctions, Accountability and Divestment Act of 2010, and has not increased or renewed such investment on or after said date. (b) If the Contractor makes a good faith effort to determine whether it has made an investment described in subsection (a) of this section it shall not be subject to the penalties of false statement pursuant to section 4-252a of the Connecticut General Statutes. A "good faith effort" for purposes of this subsection includes a determination that the Contractor is not on the list of persons who engage in certain investment activities in Iran created by the Department of General Services of the State of California pursuant to Division 2, Chapter 2.7 of the California Public Contract Code. Nothing in this subsection shall be construed to impair the ability of the State agency or quasi-public agency to pursue a breach of contract action for any violation of the provisions of the resulting contract.
- 7. Nondiscrimination Certification, C.G.S. §§ 4a-60 and 4a-60a. If a bidder is awarded an opportunity to negotiate a contract, the proposer must provide the State agency with written representation in the resulting contract that certifies the bidder complies with the State's nondiscrimination agreements and warranties. This nondiscrimination certification is required for all State contracts regardless of type, term, cost, or value. Municipalities and CT State agencies are exempt from this requirement. The authorized signatory of the contract shall demonstrate his or her understanding of this obligation by either (A) initialing the nondiscrimination affirmation provision in the body of the resulting contract, or (B) providing an affirmative response in the required online bid or response to a proposal question, if applicable, which asks if the contractor understands its obligations. If a bidder or vendor refuses to agree to this representation, such bidder or vendor shall be rejected and the State agency or quasi-public agency shall award the contract to the next highest ranked vendor or the next lowest responsible qualified bidder or seek new bids or proposals.
- **8.** Access to Data for State Auditors. The Contractor shall provide OPM access to any data, as defined in C.G.S. § 4e-1, concerning the resulting contract that are in the possession or control of the Contractor upon demand and shall provide the data to OPM in a format prescribed by OPM [or the Client Agency] and the State Auditors of Public Accounts at no additional cost.

- 9. State Business-Related Call Center and Customer Service Work: Pursuant to subsection (h) of section 31-57aa of the Connecticut General Statutes, Grantee shall perform all required state business-related call center and customer service work entirely within the State of Connecticut. If Grantee performs work outside of the State of Connecticut and adds customer service employees who will perform work pursuant to this Contract, then Grantee shall employ such new employees within the State of Connecticut prior to any such employee performing any work pursuant to this Contract.
- **10.Compliance with Consumer Data Privacy and Online Monitoring:** Pursuant to section 4 of Public Act 23-16 of the Connecticut General Assembly, Contractor shall at all times comply with all applicable provisions of sections 42-515 to 42-525, inclusive, of the Connecticut General Statutes, as the same may be revised or modified.

### **Outline for a Tobacco Use Cessation Program Curriculum**

## These specifications must be followed if an applicant is planning to incorporate direct tobacco use cessation programming activities into their proposal.

The following services must be provided at a minimum, and the applicant's approach must be addressed in the proposal:

- Provide tobacco use cessation services that are culturally and linguistically appropriate, including all education materials. All services and materials must adhere to the DHHS Clinical Practice Guidelines – Treating Tobacco Use and Dependence. <a href="https://www.ahrq.gov/sites/default/files/wysiwyg/professionals/clinicians-providers/guidelines-providers/guidelines-recommendations/tobacco/clinicians/update/treating\_tobacco\_use08.pdf">https://www.ahrq.gov/sites/default/files/wysiwyg/professionals/clinicians-providers/guidelines-recommendations/tobacco/clinicians/update/treating\_tobacco\_use08.pdf</a>
- 2) Purchase or develop in consultation with the Agency an evidence-based tobacco use cessation curriculum that includes the following: problem-solving skills and the importance of support systems, positive behavioral changes, stress management, coping skills, effects of tobacco use and the benefits of quitting, discussion of medication options and relapse prevention.
- 3) Train all staff within the organization that will be involved in the tobacco use cessation program in the policies and procedures of the tobacco use cessation treatment program and the curriculum.

Also, if program is in a clinical setting:

- a) Train healthcare providers and medical staff within the agency in the US Department of Health and Human Services, Public Health Service, Clinical Practice Guideline for Treating Tobacco Use and Dependence, including the adaptations recommended by The American College of Obstetricians and Gynecologists for treating tobacco use in pregnant women, or the adaptations recommended by The American Academy of Pediatrics for treating tobacco use in adolescents and teens.
- b) Include tracking components (ask, advise, assess, assist, arrange) into a reminder system or flow sheet for incorporation into patient records.
- c) Orient all clinic staff on the new reminder/tracking system.
- d) Assess all patients for tobacco use and implement the DHHS clinical practice guidelines into all clinical services, including but not limited to the health consequences of tobacco use, behavior modification modalities, pharmacotherapies and medical aids to control nicotine addiction, and counseling services.
- e) Refer patients using tobacco products to tobacco use cessation counseling.
- 4) Advertise and market the tobacco use cessation program to agencies and organizations that serve tobacco users in the contractor's area, using earned media and educating legislators on available services to increase referrals. Marketing and outreach activities should focus on reaching the target population(s).
- 5) Provide individual and group, face-to-face tobacco use cessation counseling sessions that are culturally and linguistically appropriate, including all educational materials at no cost to program participants.

- a) Any evidence-based Tobacco Use Cessation Curriculum must be followed for the provision of these services. Components of the cessation program must include problemsolving skills and the importance of support systems, positive behavioral changes, stress management, coping skills, effects of tobacco use and the benefits of quitting, discussion of medication options and relapse prevention.
- b) All persons enrolled must receive an initial individual intensive 30-minute counseling session, regardless of whether they choose to participate in the individual (one-on-one) or group counseling program option.
- c) Individual counseling programs must consist of no fewer than five sessions. These five sessions must be face to face, may be administered virtually at the request of the participant, and be at least 20 minutes long.
- d) Group programs must consist of no less than six sessions. Each session must be a minimum of 60 minutes long.
- e) Telephone and/or virtual counseling sessions can be used as extra support but will not be considered a substitute for face-to-face counseling if face-to-face counseling is preferred by the participant.
- f) The provision of incentives at sessions beyond the third session is encouraged in order to promote better attendance.
- g) The provision of incentives to facilitate the collection of follow-up data is also encouraged.
- 6) When medically appropriate and approved, medications (which include all FDA-approved nicotine replacement therapies and prescription medications) will be provided for up to 12 weeks per client to assist in the treatment of tobacco use dependence for program participants at no cost to the participant. Records must be kept of all medical materials purchased and provided to program participants including maintenance of an ongoing inventory if appropriate.
- 7) Provide follow up care to prevent tobacco use relapse in the form of a relapse group and/or additional individual counseling. This follow-up care curriculum will include coping and problem-solving skills, and the importance of support systems, positive behavioral changes, benefits of staying quit, strategies to manage stress, and additional cessation resources available including the CT Quitline.
- 8) Collect and input data elements into an Excel spreadsheet reviewed by DPH.
  - a) Data is collected at the following time periods to determine patient status regarding tobacco use:
    - Intake at initial enrollment/individual intensive cessation counseling session;
    - ii) Program completion or dropout;
    - iii) Follow up at four months post-enrollment;
    - iv) Follow-up at seven months post-enrollment.
  - b) Data elements to be collected include, but are not limited to, the following:
    - i) Patient Demographics
    - ii) Medical Materials Administered
    - iii) Tobacco Use Status
    - iv) Quit Status
  - c) De-identified data will be submitted monthly to the Department.
- 9) Refer patients to the CT Quitline as a secondary support system, smartphone application or other tertiary care systems to augment the cessation counseling. A referral system is in

place to easily refer patients who have given their consent to the CT Quitline provider, and an electronic medical records referral system can also be established.

- 10) Conduct a client satisfaction survey using an evaluation tool approved by the Department.
- 11)Collaborate with other entities to minimize expense and maximize services by obtaining community involvement such as through donation of refreshments, incentives, materials, or space; assistance in marketing or improving cultural relevance of the curriculum and materials, transportation assistance and childcare services.




