

Story behind the baseline:


In 2015-2016, the total student population for all 7 schools was 3.805. The total number of enrolled students with at least one visit in the SBHC was 296 (8%). The average number of visits per student was 26 (296 of 7681). There was a slight decrease in the number of students with at least one visit from 2014-2015 (307) to 2015-2016 (296).

In 2015-2016 there was considerable effort made to acquire public insurance for students who had a status of none or unknown in 2014-2015. This

resulted in a slight decrease of 1.2% in the number of students without insurance (from 25 to 21). This also affected the students with no insurance which decreased by 27.6% from 29 to 2. There were no students with other/unknown in 2015-2016 and private insurance remained consistent at 12% (36) of students served. There were 239 students with public insurance (81%).



Story behind the baseline:

In 2014-2015 170 (55%) students served by the SBHCs had at least 12 visits in a 3-month period. In 2015-2016, while the number served decreased slightly, the number served with at least 12 visits in a 3-month period increased to 191 (64%) students. Students were screened more efficiently and engaged in treatment more consistently.



Is Anyone Better Off?

Students Receiving Counseling Meeting their Goals



Story behind the baseline:

In 2015-2016, 75 students received counseling for 3 or more months. Of those, 64 (85%) attained at least one goal. This was an increase from the previous year when 65 students received counseling for 3 or more months and 55 (85%) attained at least one goal.

In 2015-2016, of the 11 (15%) students that did not meet their goals, 6 quit before completing 3 months, 3 decided not to follow up with counseling, 1 was referred to a local psychiatrist and 1 moved to another school in town. The SBHC notified the new school of the student's screener results.

Proposed Actions to Turn the Curve:

How Much Did We Do:

Survey staff to assess their knowledge of what services are available for both Mental Health and Medical at the SBHC.

How Well Did We Do:

Provide professional development on how to complete a risk assessment.

Is Anyone Better Off:

In the upcoming year a survey and interview will be done on those students who did not attain their goal, and those that went elsewhere for counseling.

Data Development Agenda:

- 1. Document in EHR (eClinicalWorks) goals that students are trying to reach and progress.
- 2. Do pre and post-test screeners on all students that receive counseling.
- 3. Work with EHR to ensure all data can be easily exported to DPH.
