

### Story behind the baseline:

In 2015-2016, the student population for all 3 schools was 1,426 and the total number of students enrolled in the SBHC was 858 (60% of the population). The number of students served was 237 (28% of enrolled). The average number of visits per student was 2.

Of the 237 students with at least one medical visit in 2015-2016, 152 (64%) were publically insured; 51 (22%) had private insurance; 34 (14%) reported no insurance.

All students enrolled in the SBHC receive care regardless of insurance status. Students/families identified as eligible for public insurance coverage are directed to one of community-based Access to Care programs.


The SBHC nurse practitioners made presentations at faculty meetings and met with parents at Back to School Nights to inform them of the mental health and medical services are offered at the SBHC.

#### How Well Did We Do?

Reduce the severity and frequency of asthma symptoms among students who utilize the SBHC



### Story behind the baseline:

In 2015-2016, 58 (24% of the students utilizing the SBHC) had a diagnosis of asthma. Of those, 20 (34%) had at least one medical visit. Of those, 5 (25%) had an Asthma Action Plan.

#### Story behind the baseline:

Is Anyone Better Off?

In 2015-2016, the SBHC began tracking the disposition of the asthma visits that students made to the SBHC.

A total of 13 asthma visits were made by students utilizing the SBHC. Of those, 13 (100%) resulted in the student being sent back to class. None resulted in the student being sent home and none of the visits resulted in a trip to the Emergency Room.

This is the first year this data is being reported and is considered baseline.
