

# Story behind the baseline:

In 2015-2016, the student population was 271 and the total enrolled in the SBHC was188 (69% of the population). The number of students served was 114 (61% of those enrolled and 42% of the school population.) The average number of visits per student was 3.3 (347 visits for 114 students).

Of the 114 students that had medical visits, 48 (42%) were publically insured, 59 (52%) were privately insured and 7(6%) had no insurance.

All students enrolled in the SBHC receive care regardless of insurance status. Students/families identified as eligible for public insurance coverage are directed to one of community-based Access to Care programs.


The SBHC nurse practitioners made presentations at faculty meetings and met with parents at Back to School Nights to inform them of the mental health and medical services that are offered at the SBHC

# Story behind the baseline:

In 2015-2016, 20 (18%) students that utilized the SBHC had an asthma diagnosis. Of those, 17 (85%) had at least one medical visit. Of those, 15 (88%) had an Asthma Action Plan.



## Is Anyone Better Off?

Reduction of visits to an Emergency Department for asthma exacerbations.



# Story behind the baseline:

In 2015-2016, the SBHC began tracking the disposition of the asthma visits that students made to the SBHC.

A total of 7 asthma visits were made to the SBHC in 2015-2016. Of those, all 7 (100%) visits resulted in the student being sent back to class and 0 (0%) were sent home. None of the visits resulted in a trip to the Emergency Room.

## **Proposed Actions to Turn the Curve:**

#### How Much Did We Do:

 Information and registration forms in English and Spanish will be provided to Welcome Center/registrar at the school for all incoming students. Information and forms will be on Agency and school websites.

#### How Well Did We Do:

 SBHC APRNs will identify any new SBHC users with asthma to determine if they have an Asthma Action Plan in place and, if one is needed, will ensure that one is developed and implemented.

## Is Anyone Better Off:

 SBHC students will track the disposition of asthma visits of new enrollees with an asthma diagnosis, making asthma visits to the SBHCs.

- Align eClinicalWorks generated reports to meet DPH requirements
- Streamline the process of exporting our data from eClinicalWorks to DPH
- Further refine data collection capability of eClinicalWorks for better identification and management of specific conditions (ex. students who have participated in select programs, students who have an asthma action plan on record, etc.)
