

## Story behind the baseline:

During the 2018-2019 school year, the total student population was 1,470. The total number enrolled in the SBHC was 533 (36%). The number of students served was 94 (18% of enrolled). The average number of visits per student was 6.1 (573 visits for 94 students). Of the 94 students utilizing the SBHC for mental health visits in 2018-2019, 32 (34%) had

public insurance, 34 (36%) had private insurance, and 28 (29 %) had no insurance.


Compared to years 2016-2017 and 2017-2018, there has been an increase in the number of students with at least one mental health visit by type of insurance.

## Story behind the baseline:

All students that are seen for a Physical Exam/Annual Wellness medical visit at the SBHC receive a mental/behavioral health screener. In 2018-2019, 52 students were seen for a physical exam/annual wellness medical visit and 51 students seen by the medical clinic received a screener. Of those screened, 7 (14%) were considered at risk



# Story behind the baseline:

In the 2018-2019 school year, 28 students participated in therapy for 3 or more months. Of those students, 8 (29%) achieved at least one goal.

#### Notes:

Funding is received from the CT DPH SBHC grant as well as reimbursements generated from services.

In 2018-2019, our subcontractor, has only been able to collect behavioral health data by provider report due to the limitations of the previous EHR Centricity. However starting July 30<sup>th</sup> 2019 CSHHC has

transitioned to a new EHR (EPIC) and will now have the ability to collect this data moving forward.

## **Proposed Actions to Turn the Curve:**

#### **How Much Did We Do:**

- Provide information to faculty at an upcoming staff development meeting to promote the services available for both Medical and Mental Health Services at the SBHC.
- Continue outreach efforts at school events promoting the SBHC services.
- Provide weekly/monthly updates to the principal on timely health topics with an action and plug to the SBHC services.
- Continue to expand the SBHC advisory committee to include new members.

#### How Well Did We Do:

- Continue to promote Behavioral Health Screening at least annually by Medical Providers- to now include annual screening even without scheduled Physical Exam/Annual Wellness visit.
- Work with new EPIC EHR to accurately document and track referrals to patients that screened as At Risk and follow up on outcomes of our screenings

## Is Anyone Better Off:

- Survey students who did not attain their goal and those that went elsewhere for counseling
- LCSW's will encourage participants to develop self-management goals, both long and short term.

 Strive to achieve the goal of at least 85% of students meeting at least 1 goal after 3 months of counseling

### **Data Development Agenda:**

- Work with EPIC in transition to new EHR (previously on Centricity EHR) to improve ability to collect data
- 2. Document in EPIC the goals that students are trying to reach and progress on each goal.
- 3. Work with EPIC to ensure all data can be easily exported to DPH.
