Pay Electronically: Visit www.ct.gov/TSC to use the Taxpayer Service Center (TSC) to make a direct payment. After logging onto the TSC, select the Make Payment Only option and choose tax type Cigarette Distributor from the drop down box.

Using this option authorizes the Department of Revenue Services (DRS) to electronically withdraw from your bank account (checking or savings) a payment on a date you select up to the due date. As a reminder, tax not paid on or before the due date will be subject to interest at the rate of 1% per month or fraction of a month on any portion that is unpaid 30 days after the purchase date.

Pay by Mail: Make check payable to Commissioner of Revenue Services. To ensure payment is applied to your account, write the "DRS date of purchase" and your Connecticut Tax Registration Number on the front of your check.

Sign your check. Do not send cash.

DRS may submit your check to your bank electronically.
