Instructions

Your motor vehicle fuels tax refund claim for diesel fuel used during calendar year 2000 must:

- 1. Be filed with the Department of Revenue Services (DRS) on or before May 31, 2001; **AND**
- 2. Include at least 200 gallons of fuel eligible for tax refund.

Be sure to provide a telephone number where you can be contacted.

You must indicate your Connecticut Tax Registration Number or Social Security Number in the space provided.

For all the purchases reported on Line 2, you must attach a copy of each numbered slip or invoice that was issued at the time of the purchase. The slip or invoice may be the original or a photocopy and must show the:

- Date of purchase;
- Name and address of the seller (which must be printed or rubber stamped on the slip or invoice);
- Name and address of the purchaser (which must be the name and address of the person or entity filing the claim for refund);
- Number of gallons of diesel fuel being purchased;
- Price per gallon; and
- Total amount paid.

Refund Rates for Diesel Fuel

Livery service vehicles (except for motor buses) are refunded at half the diesel fuel rate.

Livery Service-Motor Buses......\$.18 per gallon Livery Service Vehicles......\$.09 per gallon

Note: Complete a separate Form AU-737d for each effective tax rate.

Livery service operators (except motor buses) must attach a copy of their permit issued under Chapter 244b of the Connecticut General Statutes with each claim filed.

You must retain records that substantiate your refund claim for at least three years following the filing of the claim and make them available to DRS upon request.
