

# Form 211 CSV

## Cable, Satellite, and Video Gross Earnings Tax Return



Form 211 CSV is due on or before the last day of April, July, October, and January for the preceding calendar quarter even if no tax is due. If the due date falls on a Saturday, Sunday, or legal holiday, the next business day is the due date.

Form 211 CSV can be filed and paid electronically using **myconneCT** at [portal.ct.gov/DRS-myconneCT](http://portal.ct.gov/DRS-myconneCT).

# Form 211 CSV

## Instructions

**Form 211 CSV, Cable, Satellite, and Video Gross Earnings Tax Return**, is due on or before the last day of April, July, October, and January for the preceding calendar quarter even if no tax is due. If the due date falls on a Saturday, Sunday, or legal holiday, the next business day is the due date.

**Address Change:** To change your company's address, check the *Change of Address* box on the front of this return. Clearly print the new information.

### Rounding Off to Whole Dollars

You must round off cents to the nearest whole dollar on your returns and schedules. If you do not round, the Department of Revenue Services (DRS) will disregard the cents.

Round down to the next lowest dollar all amounts that include 1 through 49 cents. Round up to the next highest dollar all amounts that include 50 through 99 cents. However, if you need to add two or more amounts to compute the amount to enter on a line, include cents and round off **only** the total.

---

**Example:** Add two amounts (\$1.29 + \$3.21) to compute the total (\$4.50) to enter on a line. \$4.50 is rounded to \$5.00 and entered on the line.

### Line Instructions

**Line 6: Late Payment Penalty:** The penalty for underpayment of tax is 10% of the tax not paid on or before the original due date of the return or \$50, whichever is greater.

**Late Filing Penalty:** The Commissioner of Revenue Services may impose a \$50 penalty for failure to file any return or report required by law to be filed.

**Form 211 CSV, Cable, Satellite, and Video Gross Earnings Tax Return**, must be filed even if no tax is due.

**Line 7: Interest:** If you do not pay the tax when due, you will owe interest at the rate of 1% per month or fraction of a month until the tax is paid in full. To compute interest due, multiply Line 5 by the number of months or fraction of a month late, then by 1%.

**Signature:** The treasurer of the company, an authorized agent, or an officer of the company must sign Form 211 CSV.

**Paid Preparer Signature:** A paid preparer must sign and date Form 211 CSV. Paid preparers must also enter their Social Security Number (SSN) or Preparer Tax Identification Number (PTIN) and their firm's Federal Employer Identification Number (FEIN) in the spaces provided.

### Filing and Paying Electronically

**Form 211 CSV** can be filed and paid electronically using **myconneCT**. DRS **myconneCT** allows taxpayers to electronically file, pay and manage state tax responsibilities.



### Filing and Paying by Mail

If you file by mail, complete the return in blue or black ink only. Do not use staples.

If you pay by mail, make check payable to **Commissioner of Revenue Services**. Write the calendar quarter ending date of the return, "**Form 211 CSV**," and your Connecticut Tax Registration Number on the front of your check. DRS may submit your check to your bank electronically.
