Form TPM-1a - Instructions

Please note that each form is year specific. To prevent any delay in processing your return, the correct year's form **must** be submitted to the Office of the Attorney General.

Who Must File

Each nonparticipating manufacturer who sold cigarettes to consumers within Connecticut, whether directly or through a distributor, dealer, or similar intermediary or intermediaries in 2024 and deposited escrow for those sales, must deposit an additional amount representing the required inflation adjustment for the Sales Year 2024, pursuant to Conn. Gen. Stat. § 4-28i, and must also file Form TPM-1a, Supplemental Inflation Adjustment Certification of Compliance and Affidavit by Nonparticipating Manufacturer.

When and Where to File

No later than April 15, 2025, the nonparticipating manufacturer must place the required amount of money attributable to the inflation adjustment into a qualified escrow fund for Connecticut and send
