General Instructions

In accordance with Conn. Gen. Stat. 12-458a, use **Form AU-726** to file a list of distributors from whom you purchased fuel for export.

Provide a telephone number where you can be contacted in the space provided.

You must indicate your Connecticut Tax Registration Number or Social Security Number in the space provided.

Schedule of Motor Vehicle Fuel Purchased in Connecticut for Export Instructions

You must report the following information:

- List the name of the Connecticut licensed distributor from whom the motor vehicle fuels was purchased;
- List the Federal Employer Identification Number (FEIN) of the Connecticut licensed distributor from whom the motor vehicle fuels was purchased;
- List the state to which the fuel was exported. A separate line entry should be listed for each state of destination; **and**
- List the total number of gallons exported to the state listed.

1. Log in to your **myconneCT** account.
2. Click the **More...** tab.
3. In the **Correspondence** section:
 - Select **Send a Message**.
 - Select **Motor Vehicle Fuel Distributor**.

4. Compose a message and attach a copy of this form as a **PDF file with a signature**.
5. Include supporting detail as a spreadsheet.
6. Complete and send the message with the attached form.
