

Requesting a myconneCT Payment Plan

Businesses

Register a new business, file returns and make payments without creating a myconneCT username. Available forms to file non-logged on include: Attorney Occupational Tax, Estate and Gift Tax, and Controlling Interest Tax. For other returns and filing options, login with your Connecticut Registration Number.



Payment Plan Information

This request will allow you to set up a Payment Plan Agreement for eligible periods. If you recently filed a return with a balance due, that due amount will NOT be available for a payment plan until the return is processed by the Department of Revenue Services. You will be notified via Web Notice/Email once your return has been processed by the DRS.

- The current outstanding balance may be subject to additional penalty and interest charges if the total amount due is not paid in full.
- The myconneCT Payment Agreement must be paid in full within a 12 month period. If you are unable to pay your tax liability in full within 12 months, pay as much as you can afford today and contact a Revenue Agent at 860-297-4936 to establish an acceptable repayment schedule. Agreements with balances greater than or equal to \$50,000 cannot exceed 12 months.
- In addition to the repayment terms, all future tax returns must be filed and paid on a timely basis as required by Connecticut law. Failure to make payments by the due date, incurring any additional tax liability, or failure to notify us of any changes in your circumstances, may result in enforcement action for the full amount, without any further notification. Monthly payments continue to be due on these unpaid bills even if we offset your refund and apply it to your bill
- · Payments will be debited from your bank account automatically each month.
- The down payment due date cannot be changed after finalizing the payment plan.
- . The latest date to change the first installment due date is 3 days before that payment is due.
