Obtaining Connecticut Publications in Booklet Form

Purpose: This Announcement provides information about obtaining copies of informational publications in booklet form.

Effective Date: Effective when issued.

DRS Publications: The Department of Revenue Services (DRS) produces a variety of publications which contain tax information, such as Special Notices, Policy Statements, Announcements, and Informational Publications. These publications are available on the DRS website at www.ct.gov/DRS for reading and downloading at no cost. Most of these publications are one to four pages in length and DRS does not charge for these publications or for the cost of mailing single copies. However, DRS produces three publications in booklet form: **Informational Publication 2006(35)**, *Building Contractors' Guide to Sales and Use Taxes*; **Informational Publication 99(18)**, *Sales and Use Taxes Guide for Manufacturers, Fabricators, and Processors*; and **Informational Publication 2006(15)**, *Guide to Connecticut Business Tax Credits*.

Obtaining Informational Booklets: Because of the costs involved in reproducing and mailing the booklets, DRS limits distribution of these publications to one copy per request.

There is no charge for a copy of any publication in booklet form if it is picked up at the DRS main office in Hartford or in its field office locations. Please call the location at the telephone number listed below before you visit to be sure copies of the publication you want are available.

Paperless Filing/Payment Methods (fast, easy, free, and confidential):

- **For business returns:** Use *Fast-File* to file sales and use taxes, business use tax, room occupancy tax, estimated corporation business tax, business entity tax, attorney occupational tax, nursing home provider fee, admissions and dues tax, or withholding tax returns over the Internet. Visit the DRS website at www.ct.gov/DRS and click on *File/Register OnLine*.

- **For payment of business taxes other than those listed above:** Use *Fast-File* to pay your business taxes over the Internet or by phone. Visit the DRS website at www.ct.gov/DRS and click on *Electronic Services* for a list of eligible taxes. The ACH debit method is used to make the transfer. No preregistration is required.
 - **For resident income tax returns:** Use *WebFile* to file personal income tax returns over the Internet. Visit the DRS website at www.ct.gov/DRS and click on *File/Register OnLine*.
 - **For electronic filing of income tax extensions, estimated payments, and for electronic bill payments:** Use *WebFile* to electronically file personal income tax returns over the Internet. You can also use *WebFile* to make an electronic income tax payment for a prior year. Visit the DRS website at www.ct.gov/DRS and click on *File/Register OnLine*.
