## Motor Vehicle Fuels Tax Rate on Diesel Fuel Effective July 1, 2020

**Purpose:** This Announcement notifies taxpayers of the motor vehicle fuels tax rate per gallon on the sale or use of diesel fuel that goes into effect for the 12-month period beginning July 1, 2020.

Effective Date: July 1, 2020.

**Statutory Authority:** Conn. Gen. Stat. § 12-458(a)(2), and Conn. Gen. Stat. § 12-458h.

**Decrease in Motor Vehicle Fuels Tax Rate on Diesel Fuel:** The Commissioner of Revenue Services has calculated the new diesel fuel tax rate for the 12-month period beginning July 1, 2020. Effective July 1, 2020, the diesel fuel tax rate is  $44.6\phi$  per gallon, which will remain in effect through June 30, 2021. This represents a  $1.9\phi$  decrease to the tax rate from the prior fiscal year  $(46.5\phi)$  per gallon.

**Effect on Other Documents:** The following forms have been revised to reflect the rate on diesel fuel discussed in this Announcement for the 12-month period effective July 1, 2020, through June 30, 2021.

- Form AU-741, Motor Vehicle Fuels Tax Refund Claim, Commuter Vans.

**Effect of This Document:** Announcements alert taxpayers to new developments (other than newly enacted or amended Connecticut or federal laws or newly released judicial decisions), including new administrative positions, policies, or practices.
