## **Motor Vehicle Fuels Tax Suspension Extended Through November 30, 2022**

---

**Purpose:** The Department of Revenue Services (DRS) is making distributors, sellers, and consumers aware of recent legislation that effectuates an extension to the motor vehicle fuels suspension through November 30, 2022.

---

**Effective Date:** From passage.

---

**Statutory Authority:** *2022 Special Act 2, § 1, as amended by 2022 Conn. Pub. Acts 118, § 431.*

---

### **Suspension of the Motor Vehicle Fuels Tax:**

In accordance with recent legislation that was signed by Governor Ned Lamont, the motor vehicle fuels tax is suspended through November 30, 2022.

Section 1 of 2022 Special Act 2, signed by Governor Ned Lamont on March 24, 2022, suspended the application of the motor vehicle fuels tax to gasoline and gasohol between April 1, 2022, and June 30, 2022.

Section 431 of 2022 Conn. Pub. Acts 118, signed by Governor Ned Lamont on May 7, 2022, extended the suspension of the motor vehicle fuels tax to gasoline and gasohol through November 30, 2022.
