HELPFUL TIPS FOR THE INDIVIDUAL INCOME TAX FILING SEASON

If you do not have all the information to file your Connecticut income tax return by April 15:

Complete **Form CT-1040 EXT**, *Application for Extension of Time to File Connecticut Income Tax Return for Individuals*, to request a six-month extension of time to file. (This does not grant you an extension of time to pay.)

If you do not have enough money to pay your Connecticut income tax by April 15:

Make sure to file your return on time and pay as much as possible. DRS understands that there are times when taxpayers experience temporary, legitimate financial difficulties and require extra time to pay a tax debt. To determine if you qualify for a payment plan, see the **[Installment Agreement Request](#)**.

There are two main options to make an individual income tax payment:

- Option one:
 - Pay electronically through **myconneCT**.
 - Pay by ACH Debit/Direct Payment: Using this option authorizes DRS to electronically withdraw a payment from your bank account (checking or savings) on a date you select up to the due date.
 - Pay by Credit Card or Debit Card: You may elect to pay your tax liability using a credit card (American Express®, Discover®, Master Card®, Visa®) or a comparable debit card. A convenience fee will be charged by the credit card service provider. You will be informed of the amount of the fee and may elect to cancel the transaction. Your payment will be effective on the date that you make the charge.
- Option two:
 - Pay by check - see the mailing addresses below:

If eligible, you can check the status of your tax refund. Click on the *Where's my Refund?* hyperlink in the individual panel of the **myconneCT** home page and follow the prompts.

SPOTLIGHT: EARNED INCOME TAX CREDIT

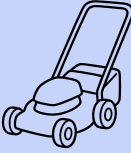
You worked for it, you earned it, now don't forget to claim it!

The CT EITC is a refundable state income tax credit for low to moderate income working individuals and families. The state credit mirrors the federal EITC and is now 40% of the federal credit. CT's EITC is one of the highest rates in the country, and last year, the Connecticut General Assembly voted to add a \$250 credit for families with at least one qualifying child. When both the federal and CT EITC amounts exceed the amount of taxes owed, it results in a tax refund to those who claim and qualify for the credit.

To qualify for the CT EITC, you must be eligible for the federal EITC, be a Connecticut resident, have earned income from employment, self-employment or another source, and meet certain rules. For more information, visit the **[CT Earned Income Tax Credit page](#)** on the DRS website.



SEASONAL TAX TOPICS



Spring is in the air! Take a look at the spring chores that are taxable (or not):

Repair or Maintenance Service to Any Item of Tangible

Personal Property:

Bike Repair / Tune-Ups

Get ready to hit the trails and bike paths! Repair and maintenance services for bicycles are subject to sales and use taxes.

Landscaping Equipment / Maintenance Repair

Prepare your landscaping equipment before peak season begins. Maintenance and repair services for lawn mowers, trimmers, and blowers are subject to sales and use taxes.

Window Cleaning

Let the sunshine in this season! Window cleaning services, including interior and exterior glass cleaning, are subject to sales and use taxes.

Landscaping and Horticulture Services:

Irrigation System Startup / Repair

Watering your grass may mean repairing your irrigation or sprinkler system. Irrigation system startup/repair services are subject to sales and use taxes.

Lawn Care Treatment

Time to get your lawns fertilized and your plants ready for spring! Lawn care treatment is subject to sales and use taxes.

Repair or Maintenance Service to Real Property:

Carpet Cleaning

Carpet cleaning is one less thing to sneeze about! Cleaning your carpet clears the air, and this service, performed at a customer's residence, is subject to sales and use taxes.

HVAC Inspection and Tune-Ups

Schedule seasonal HVAC inspections to help avoid unexpected breakdowns. In general, HVAC system maintenance and repair services are subject to sales and use taxes.

Power Washing

Time to wash away all the winter snow! Maintenance and cleaning services, including power washing, are subject to sales and use taxes.

Roofing Repair / Replacement

A tough New England winter can take a toll on your roof. Now is a perfect time to schedule a post-winter inspection with a local roofer. Roof repairs or replacement for parts of a roof or for an entire roof, if performed on owner-occupied property, is not subject to sales and use taxes.
