

LEGISLATIVE HIGHLIGHTS



The 2025 legislative session convened January 8, 2025, and adjourned June 4, 2025.

The General Assembly passed a significant amount of tax related legislation during the 2025 session that impacted several of the taxes administered by the DRS. Some of the notable pieces of legislation include an expansion of the Earned Income Tax Credit that provides an additional \$250 to eligible taxpayers, the establishment of a farm investment tax credit, the suspension of the withholding requirement on "lump sum distributions" and the extension of the 10% surtax on corporations, just to name a few.

2025 Filing Statistics

Another successful tax filing season is on the books! Over 1.8 million Connecticut income tax returns were received during the 2025 filing season. As outlined in the charts below, the DRS' Contact Service Center answered over 183,000 phone calls and met in person with over 3,000 taxpayers at our 450 Columbus Boulevard Hartford Walk-In Office. In addition, both the DRS eAssistant and a variety of targeted webinars also proved to be new and valuable tools for taxpayers. Registration is Now Available for Businesses Subject to the Aviation Fuel Tax Return

A company that distributes or imports fuel into the state of Connecticut for consumption in the state is required to complete a registration application for aviation fuel and must pay tax on the first sale of aviation fuel. The application must be completed to file **Form DRS-AVT**, *Aviation Fuel tax Return*. The aviation fuel tax is effective beginning July 1, 2025, and must be filed on a quarterly basis. If applicable, the first return and payment must be filed on or before October 31, 2025. The registration application is available on **myconneCT** at **portal.ct.gov/DRS-myconneCT**. 
Janitorial Services and Maintenance Services

UPCOMING TAX FILING DUE DATES

Alcohol Beverage/Distributor Tax:

Form O-255, Wholesale Alcoholic Beverages Tax Return, must be filed on or before the last day of the month following the end of the filing period.

Aviation Fuel Tax:

Form DRS-AVT, *Aviation Fuel Tax Return*, must be filed on or before the last day of the month following the quarter. The first Form DRS-AVT return is required to be filed on or before October 31, 2025, for the July quarterly filing period.

Beverage Container Deposit:

Form OP-515, *Beverage Container Deposit Report*, must be filed on or before the last day of the month following the quarter.

Cigarette Tax:

Resident and Nonresident distributors must file Form CT-15, Connecticut Monthly Tax Stamp and Cigarette Report - Resident Distributor and/or Form CT-15A, Connecticut Monthly Tax Stamp and Cigarette Report - Nonresident Distributor, on or before the twenty-fifth day of the month following the month for which the report is made.

UPCOMING TAX FILING DUE DATES CONTINUED



Corporation Business Tax Return:

Form CT-1120, Corporation Business Tax Return, on or before the fifteenth day of the month following the due date of the corporation's corresponding federal income tax return for the income year (May 15, for calendar year filers). Exception for June 30th year ends: If a corporation has a June 30th year end, the return is due on October 15.

Income Tax:

Form CT-1040ES, 2025 Estimated Connecticut Income Tax Payment Coupon for Individuals, for the 3rd quarter must be filed on or before September 15.

Petroleum Products Gross Earnings Tax:

Form OP-161, Petroleum Products Gross Earnings Tax Return, must be filed on or before the last day of the month following the guarter.

Prepaid Wireless E-9-1-1 Fee:

Form OP-153, Prepaid Wireless E 9-1-1 Fee Return Enhanced Emergency 9-1-1 Program, is due on or before the last day of the month following the end of the filing period. The filing period is the same as for sales and use tax except annual filers must file Form OP-153 quarterly.

Sales and Use Tax:

Form OS-114, Connecticut Sales and Use Tax Return, to report all sales activity in Connecticut, even if no sales were made or no tax is due. Both taxable and nontaxable sales must be reported in accordance with monthly, quarterly, or annual filing frequency assigned by DRS. Form OS-114, must be filed on or before the last day of the month following the end of the filing period.

Special Fuel Tax:

Form OP-216, Special Fuel Tax Return, must be filed on or before the twenty-fifth day of the month following the end of the filing period.

Tourism Surcharge:

Form OP-337, Tourism Surcharge Return on the Rental/Leasing of Passenger Motor Vehicles, must be filed on or before the last day of the month following the end of the filing period.

Withholding Tax (Employers):

Wage Withholding - Form CT-941, Connecticut Quarterly Reconciliation of Withholding, must be filed on or before the last day of the month following the guarter.
